Respected Sir,

In producing herewith one arrested accused person namely Subhrangshu Bauri @ Bapi (25 yrs) S/O- Anil Bauri of Vill- Dumursole, P.S- Tamna, Dist.- Purulia with seizure list and seized articles, I beg to submit that today i.e on 30.07.2021 at about 04:45 hrs during special mobile duty, received a secret source information and as per order of O/C Tamna PS, I SI Bikash Ch. Patra of Tamna PS along with force had been to Dumursole village under Tamna PS at 05:25 hrs and as per indication conducted raid in the house of Subhrangshu Bauri @ Bapi (25 yrs) S/O- Anil Bauri of Vill- Dumursole, P.S- Tamna, Dist.- Purulia and found 2/3 persons fled away from his house and detained one person. On asking his identity he disclosed his identity as noted above. On interrogation he confessed his guilt for selling and possession of country spirit styled as DILKHUSH & ID Liquor. On demand he failed to produce any valid documents in respect of stock and selling of said country spirit styled as DILKHUSH & ID Liquor at his own house. As such I seized (i) 10 (Ten) Liters of ID Liquor in a plastic container, (ii) 26 (twenty six) sealed Bottles of country spirit styled as DILKHUSH each bottles contains 300 ml. One bottles taken from country spirit styled as DILKHUSH of 300 ml. and some portion of ID Liquor as sample under proper Seizure List in presence of witnesses and signed by witnesses and accused person. Arrested the above noted accused person after observing all legal formalities regarding arrest. Informed him the ground of his arrest. The seized articles were properly sealed and label in presence of witnesses duly signed by them and accused person.

The above noted accused person namely Subhrangshu Bauri @ Bapi (25 yrs) S/O- Anil Bauri of Vill- Dumursole, P.S- Tamna, Dist.- Purulia committed offence u/s- 46 A(c) B.E. Act- 1909 for unauthorized possession and sales of ID Liquor & country spirit (DILKHUSH) from his house.

Under the fact and circumstances kindly take necessary lawful action against Subhrangshu Bauri @ Bapi (25 yrs) S/O- Anil Bauri of Vill- Dumursole, P.S- Tamna, Dist.- Purulia.
