In producing herewith one arrested accused person namely Subhrangshu Bauri @ Bapi (25 yrs) S/O- Anil Bauri of Vill- Dumursole, P.S- Tamna, Dist.- Purulia with seizure list and seized articles, I beg to submit that today i.e on 30.07.2021 at about 04:45 hrs during special mobile duty, received a secret source information and as per order of O/C Tamna PS, I SI Bikash Ch.
