Sir,

In producing here with one arrested accused namely Manoj Shaw (40 Yrs) S/O Lt. Hira Shaw of Sabji Market Samity Chaigada Adra, PS-Adra, Dist- Purulia along with following seized articles with seizure list and Memo of Arrest.

1) 16 bottles DIL KHUSH country spirit, 600 Ml. each Rs/-50 of each bottle.

I SI Ashoke Kumar Mahata of Adra PS do here by lodged a complaint against accused namely Manoj Shaw (40 Yrs) S/O Lt. Hira Shaw of Sabji Market Samity Chaigada Adra, PS-Adra, Dist- Purulia to the effect that on 01/08/21 at about 21:45 hrs I received a information from a reliable source that one Manoj Shaw has been stock of country spirit illegally at his house at Sabji Market Samity Chaigada Adra Adra during my special mobile duty vide CC No-3055/21 dtd.01.08.21. After getting such information I along with my accompanied force left for Sabji Market Samity Chaigada Adra Adra to work out the Information. We reached at Sabji Market Samity Chaigada Adra Adra, at about 22:05 hrs and hold raid in the house of said Manoj Shaw and found that the said person selling liquor at his house and after seeing the Police party some person fled away and said Manoj Shaw has tried to concealed himself but I able to apprehend him with the help of accompanied force and also detained him. I asked him to produced valid License or valid papers for selling country spirit but he failed to produce any valid license or documents for possessing /selling the same. So it is sufficient reason to believe that said Manoj Shaw selling the country spirit by illegal way. I seized the above mentioned articles under proper seizure list duly sign by accused person and available witnesses and arrested the above mentioned accused person informing the ground of arrest. The complete process was done in between 22.05 hrs to 22.25 hrs.

Hence I there for pray that a specific case may kindly be started against arrested accused Manoj Shaw (40 Yrs) S/O Lt. Hira Shaw of Sabji Market Samity Chaigada Adra, PS-Adra, Dist- Purulia under proper section of law.
