In producing herewith 13 (Thirteen) arrested accused persons namely 1) Rabi Mondal (19 Yrs) S/O Madhu Mondal of Chakalta (2) Nabik Mondal (20 Yrs) S/O Kittan Mondal of Vill-Chakalta (3) Swarup Mondal (19 Yrs) S/O Goutam Mondal of Chakalta (4) Md.Sahayad (19 Yrs) S/O Lt. Md. Nousad of Palashkola (5) Nayan Bauri (21 Yrs) S/O Lt. Samir Bauri of Kalikend (6) SK. Irfan (44 Yrs) S/O Lt. SK. Rashid of Palashkola (7) Balmiki Pandey (40 Yrs) S/O Ramakanta Pandey of Kantaranguni,(8)Anindya Kr. Mukharjee (22 Yrs) S/O Achinta Kr. Mukharjee of Palashkola all are PS-Adra, Dist-Purulia and (9) Binod Mondal (35 Yrs) S/O Lt. I beg to state that, today (02.08.2021), I was directed to find out whether the guidelines of Govt regarding not wearing face musk in public and restriction of movement accept emergency from 21:00 hrs to next day 05:00 hrs in this pandemic situation has been implemented properly at Adra Bazar area or not. Accordingly, I had been to near Bilmoriya More along with force vide Adra PS CC NO-2063 dtd.02.08.2021 at about 21.05 hrs and found that a gathering appeared near Bilmoriya More none of them was wearing face musk. On seeing Police party they have tried to escape from the grip of police party but thirteen failed to escape due to efficiency effort of police party. On being asked they disclosed their identity as noted above.

They violated the order duly promulgated by government through public servants and through media etc for prevention of attack from CORONA Virus/COVID-19. They are creating annoyance to the society & violated govt. order. Though in view of Pandemic of COVID-19 outbreak vide Govt. of India order No- 79-CS/2020 dated 12.04.2020 of the Government of West Bengal, Wearing of face mask has been mandatory in public places and restriction of movement accept emergency from 21:00 hrs to next day 05:00 hrs in the current pandemic disaster situation. Whereas, vide advisory issued vide no- 715-Home (Cons)/RIM(Cons)-92/2021dated- 17.04.21, followed by restriction order No. 753/IV – ISS / 2M-22/2020 Dated. 29/07/2021 of Government of West Bengal has stressed that any violation of musk and social distance norms should be strictly dealt with.

Larrested them for disobedience to order duly promulgated by public servant after maintaining all rules of arrest, Issued memo of arrest & Inspection Memo. I informed them & their relative regarding the ground of arrest provide penalties for disobeying any regulation or order made under the Act. These are according to Section 188 of the Indian Penal Code (Disobedience to order duly promulgated by public servant). A prima facie there were sufficient evidences to secure their detention. All the process was done at 21.15 hrs to 22.25 hrs. There was every chance of speared of Infection of disease COVID-19(CORONA VIRUS) which is endanger of human life.

Therefore, I pray a specific case U/S 188/34 IPC and Section 51(1)(b) National Disaster Management Act- 2005 may kindly be lodge against 13 accused persons as noted above. As they disobeyed Govt. order and committed negligent Act likely to spread infection of diseases which is dangerous to lie and arrange for investigation.
