Sub: Prayer for starting a specific case against (1) Dinesh Shaw (52 Yrs) S/O Lt. Mahadeo Shaw of Kamlasthan, PS-Adra, Dist-Purulia.

Sir.

In producing here with the arrested accused persons namely (1) Dinesh Shaw (52 Yrs) S/O Lt. Mahadeo Shaw of Kamlasthan, PS-Adra, Dist- Purulia, as disclosed by the arrested accused persons along with seized articles under proper seizure list (enclosed here with) i.e. (i) Exhibit Mark-'A'- 500 grm. Cannabis (Ganja) like substance packed & labeled (ii) Exhibit Mark-'B'- 100 grm of Cannabis (Ganja) like substance taken from Exhibit-A as test sample marked and labeled. (iii) Exhibit Mark-"C"-. 100 grm of Cannabis (Ganja) like substance taken from Exhibit-A as security sample marked and labeled (iv) Exhibit Mark-"D"- One black colour plastic bag (v) Exhibit Mark-"E"- One Gray Colour Bag made by cloth. All Exhibits are in properly sealed and labeled condition under proper seizure list.

I, SI Sourav Banerjee of Adra PS do here by Jodge this complaint as suo-moto to the effect that today (07/08/2021) at 21:25 hrs received a secret information from my source that 01 (one) persons would be coming from Palashkola side and may proceed towards Adra Bus Stand side through Adra - Kashipur Pitch road with some contraband goods suspected to be narcotic substance in order to sell the same. On received such information I immediately diarized the fact in GD vide Adra PS GDE No 298 dated-07.08.2021 and informed the matter to IC Adra PS who please directed me to proceed to work out the information. I send massage to SDO, Raghunathpur through E-Mail to depute one executive magistrate to accompany in the search and seizure process through Adra PS G-mail. As per direction of I/C Adra PS I SI Sourav Banerjee along with (i) ASI- Falguni Sarkar (ii) C/1434 Jagannath Mondal (iii) C/174 Tapan Das Bauri (iv) CD156 Deb Dulal Majhi, all are Adra P.S. left at 21:35 hrs for Kashipur More near Adra Bus Stand i.e. Adra Kashipur Pitch Road, after preparing inventory list, by Govt. Vehicle No WB 56C/8995 attached to Adra PS equipped with govt. supplied arms and ammunition, weighing machine, investigation kit box, white paper, gala, white cloth, carbon paper, stamp pad, seal of Adra PS, brown envelope etc. vide Adra PS CC No. 3018/21 Dt. 07.08.2021 & Adra PS GDE No-299 dt. 07.08.2021.

At about 21:45 hrs reached Kashipur More near Adra Bus Stand i.e. Adra Kashipur pitch road under Adra PS. After reaching, the said Govt. vehicle was kept in reasonable distance conducted ambushed up to 22:05 hrs on 07.08.2021. In that mean time IC Adra PS reached at Kashipur More near Adra Bus Stand. At that time found 01 (one) persons approaching towards Adra Bus Stand Side by foot from Palashkola side with a bag. While he reached closer to police party we surrounded him and focused our torch light and detained him. On asked he disclosed his identity as (1) Dinesh Shaw (52 Yrs) S/O Lt. Mahadeo Shaw of Kamlasthan, PS-Adra, Dist- Purulia. We informed him that we have specific information that he has illegal narcotic substance and he admitted that he procured and carrying Cannabis (Ganja) which is use as contraband narcotic substance without any valid papers and others.

In the meantime one Bikram Pratap Singh S/o Lt. S.M Singh of Lower Jhariadih Adra, and 2) Ajay Shaw @ Bachu S/O Baidyanath Shaw of Vill- Laldanga, both of PS - Adra, Dist.- Purulia who were returning to their home via Adra Kashipur pitch road on bike and reached at Adra Bus Stand, IC Adra PS requested them to wait for some while as disinterested witnesses, as because we will be ready to search the above noted one detained persons in presence of them.

i also issued notice as per NDPS Act and as per order of IC Adra PS to the detained person in order to conduct his search by a Executive Magistrate or by any Gazetted Police Officer. He informed in writing that he has no objection if the search conducted either by any Gazatted Police Officer or by any Executive Magistrate.

Insp. Partha Pratim Roy, IC Adra PS informed me that no Executive Magistrate could be made available as such odd hours of the night. Insp. Partha Pratim Roy, IC Adra PS disclosed his identity before the detained person and asked me to issue notice to the detained persons, offering him to search the available police personnel present there as well as the public witness present there, but he showed no interest and refused to conduct any search of the police personal and public witness in writing.

As per direction of IC Adra PS, I conducted search of (1) Dinesh Shaw (52 Yrs) S/O Lt. Mahadeo Shaw of Kamlasthan, PS-Adra, Dist- Purulia, in between 22:25 hrs to 23:05 hrs.

During search I recovered one gray colour clothing bag in which found one black colour plastic bag containing Cannabis (Ganja) like substance. On interrogation he confessed that it is the Cannabis (Ganja) and he is habituated in dealing of such clandestine illegal business of Cannabis (Ganja) for selling purpose for his wrongful gain, knowing the same is a punishable offence. On demand he failed to produce any documents or justify regarding the storage of Cannabis (Ganja). According to the direction of IC Adra P.S I weight the Cannabis (Ganja) and it resulted total in 500 grams in weighting machine. On reasonable belief, an offence has been committed in respect of recovered substance believe to be Cannabis (Ganja) from which 100 Gram were taken in 02 (Two) brown envelope as test samples and security samples from mother sample. The said articles were seized U/S 43 of NDPS Act 1985 under proper seizure list duly signed by the witnesses as well as the accused person. I also supplied a copy of seizure list to the accused person. I arrested the detained person maintaining all formalities. The seized articles were properly labeled and sealed.

I prepared another inventory list containing weighting machine, investigation tool kit, some white paper, used gala, rest white cloth, used carbon paper, stamp pad, seal, burnt candle, mother samples consists of 300 gram Cannabis (Ganja) like substance in black plastic and two brown envelop contains 100 gm Cannabis (Ganja) like substance in presence of witnesses and accused persons. The entire process was supervised and directed by IC Adra PS, Sri Partha Pratim Roy.

Accused person was medically checked up at Raghunathpur SD/SS hospital on 07/08/2021 and after returning at PS seized Alamats and samples were deposited to the Malkhana dealing Officer and kept at PS Malkhana.

At PS the accused person further searched by Police personnel and put him into the PS lock up after observing all Hazat rules and informed on duty table Officer and caution the sentry duty.

That, I the complainant drafted and prepared the complaint by typing on going through the records of the Case. The relative of the arrested accused person is being informed.

The accused persons are liable for prosecution U/S-21(a) of NDPS Act. 1985 as amended up to date.

Under the above fact and circumstances I like to lodge an FIR against (1) Dinesh Shaw (52 Yrs) S/O Lt. Mahadeo Shaw of Kamlasthan, PS-Adra, Dist-Purulia, U/S-21 (a) of NDPS Act 1985 as amended up to date and arrange for its investigation.
