In producing herewith one arrested person namely Apu Paramanik (52 yrs) S/O Lt. Shankar Paramanik of Vill- Rangamati, PO-Malancha, PS – Kashipur, Dist- Purulia along with seized vehicle (Tractor) bearing WB 81/1226 and Eng. No-RHE2EAN5442, Chassis number not traced along with sand loaded Trolley without number plate seized under proper seizure list and memo of arrest in respect of the supra person before you.

The nub of the fact in a nutshell is that today 21.08.2021 while I along with force namely 1) C/1274 Ganesh Ch. Saha 2) HG/1886 Nandalal Paharia left the PS for performing Day petrol duty vide CC No 3148/21 Dated 21.08.2021 and Adra PS GDE no 870 Dated 21.08.2021 in PS area. During my petrol duty, I received a tip off at 12:05 hrs that a suspicious tractor loaded with sand was coming from Gagnabad village side towards Kalikend, Adra, Purulia. Subsequently, I along with force proceeded towards Kalikend village to work out the tip off. While I along with force arrived at Kalikend village near Pry. School I asked local people who gathered at that place to become witnesses but none came forwarded and all of them left the place. After that I found that one tractor was coming from Gagnabad village side under Adra PS. I along with force intercepted the vehicle (Tractor) bearing WB 81/1226 attached with Trolley loaded with sand after placing the guardrail on the road at 12:25 hrs at Kalikend village near Pry. School and found that the vehicle as well as goods as identical as I received prior information. On being asked, the driver of the said vehicle disclosed his name noted in the supra. I asked the driver of the vehicle to produce the valid documents in respect of the vehicle as well as the loaded sand. But the driver of the said vehicle could not able to produce any kind of documents in respect of the Tractor and the sand. I repeatedly asked the driver to produce the valid paper but he stated differently in different times. The incoherent statement of the driver purported to be a suspicious one to us. It was ascertained that the driver of the said tractor loaded the said sand in cahoots with the owner of the vehicle by illegal means for selling the same to make profit by dishonestly and they had been running a clandestine business. So it is reasoned to belief that he in cahoots with the owner of the vehicle procured the said sand from Darkeswar River at Royal Bhata Ghat (Suriya Mouza) side by fraudulently means or theft by any means for transporting the same to run clandestine business. During interrogation the driver clearly confessed that he habitually deal with the clandestine business and assisting in concealment and disposing voluntarily of stolen sand in a clandestine manner since years, also violating the Govt. notification/order. They also violating the order notification vide DM, Purulia Memo No - VI/430 (Part -VIII)/1176/M/90/M/17 Dtd.26.06.2020, regarding ban of sand lifting from Riverbed. So I, seized the tractor bearing WB 81/1226 attached with Trolley loaded with sand under proper seizure list in presence of available witnesses duly signed by them and also arrested the driver namely Apu Paramanik (52 yrs) S/O Lt. Shankar Paramanik of Vill- Rangamati, PO-Malancha, PS - Kashipur, Dist- Purulia after informing the ground of arrest and issued Memo of Arrest against him. Thereafter, I brought the said tractor to Adra P.S.

Under the above facts and circumstances kindly take lawful action against the driver namely, Apu Paramanik (52 yrs) \$/O Lt. Shankar Paramanik of Vill- Rangamati, Podalancha, PS - Kashipur, Dist- Purulia and the owner of the vehicle vide Reg. No- WB 81/1226 as they committed offence U/S 188/379/411/414/120B of the IPC & 21 (1) (4) Mines and Minerals (R&D) Act-1957.
