Sir,

In producing herewith arrested accused person namely Sourav Mandi (22 Yrs) S/O Ramsing Mandy of Vill-Moraldi, PO-Godibero, PS-Santuri, Dist- Purulia along with seized articles (1) One red colour Hero Honda Super Splendor Motor Cycle bearing Reg. No-WB 44C/0559, Eng. No-JA05EBB9K03852 and Chassis No-MBLJA05EGB9K06250 along with all connected papers.

I beg to report that today myself along with C/312 Radheshyam Mandal, C /624 Pradip Chakraborty and C/41 Dinesh Bauri all of Adra PS were performing special NAKA checking duty at Kalimore, Adra under Adra PS area vide Adra PS Misc C.C No-3176/21 dtd.24.08.2021 and Adra PS GDE No-1009. At about 16:00 hrs, I found one motor Cycle bearing Reg. No- WB 44C/0559 coming from Adra rail gate side rashly and negligently. We try to stop him but the driver of the said motorcycle named in above was trying to escape the place so rashly, there was every possibility of loss/ serious injury of nearby public due to his such driving. After a hot chase we could able to stop him. On being asked, he stated his name and address as noted above, but unable to give any satisfactory account for his such rush and negligent driving which may cause endanger to human life.

So, I seized the motor cycle and arrested him as he violated sec 279 IPC at about 16:15 hrs. with a view to prosecute him U/S 279 IPC in presence of witnesses. The whole process of seizure was completed in between 16:05 hrs to 16:15 hrs. His family member was also informed about the ground of arrest.

Hence I pray that a specific case U/S 279 IPC may kindly be initiated against accused Sourav Mandi (22 Yrs) S/O Ramsing Mandy of Vill-Moraldi, PO-Godibero, PS-Santuri, Dist- Purulia.
