Sir,

In producing herewith the arrested accused persons namely (1) Nayan Gorain (31 Yrs) S/O Mihir Gorain (2) Mihir Gorain (51 Yrs) S/O Satish Ch. Gorain (3) Rajat Gorain (36 Yrs) S/O Nitai Gorain (4) Timir Gorain (41 Yrs) S/O Satish Gorain (5) Tapas Gorain (42 Yrs) S/O Ajit Gorain (6) Ajit Gorain (62 Yrs) S/O Lt. Amulya Gorain all are Vill-Jiara, PS-Adra, Dist- Purulia (7) Ganesh Mahato (30 Yrs) S/O Mahadev Mahato of Vill-Monipur, PS-Adra, Dist- Purulia before you, along with seized articles like board money amounting to RS- 5,380/-, 52nos of playing cards, from their possession etc. as per seizure list.

I beg to report that on 24.08.2021 at 21:25 hrs, I/C Adra PS received secret information that one gambling with huge amount was going on at Action Club under Jiara Village. The matter was diarized vide Adra PS G.D.E No-1025 Dtd.- 24.08.2021. Accordingly as per order of I/C Adra PS I S.I Madan Ch. Supakar along with (1)C/2168 Sukanta Lohar (2) HG/1876 Nandalal Pahariya (3) C/ 2541 Ajay Giri (4) JC 1481 Shibu Gope vide C.C No- 3182/21 in Govt. vehicles left for Jiara Village to work out the information. At about 21:55 hrs we reached at Jiara village and very slowly and cautiously approached towards Action Club where the gambling was reportedly going on. From the outside of the club we over heard the talking of persons present there and within a few moment it was clear that the persons present there were continuing gaming with playing cards in exchange of money causing wrongful loss to one and wrongful gain to another. After that I asked my associate staffs to cordon the place and within a moment the place was cordoned by Police party. We disclosed our identity and then some persons fled away but we were able to apprehend the above noted persons. Then, I requested them to search myself and my other staff accordingly the persons searched ourselves and found nothing except wearing apparels (Police Uniform with nameplates) and Mobile Phones. After that we asked their identity and the persons disclosed their name and address as noted above. It was found that a huge amount of currency note of different denomination were kept on gaming board (One Yellow colour and one green colour Plastic torn sack on the floor) and playing cards were also found. Noted that sufficient electric light is present inside of Action Club. On demand the persons clearly confessed that all of them were doing gambling with playing cards in exchange of cash and coin for wrongful loss to one and wrongful gain to another. After that in presence of police party the board money of Rs 5,380/- (Five thousand three hundred eighty Rupees only) with different denomination, 52nos of Playing cards and One Yellow colour and one green colour Plastic torn sack were seized for the gaming board in between 22:05 hrs to 22:35 hrs under proper seizure list.

As such for committing offence punishable u/s- 3 & 4 of W.B.G & P.C Act all the above noted 07 (Seven) persons were arrested, issuing arrest memo at 22.05 hrs.

Therefore I pray before you that one specific case may kindly be start under proper section of law against the above noted accused persons and arrange for its investigation.
