In producing herewith arrested accused person namely Lalchand Mondal (21 Yrs) S/O Mihir Mondal of Vill-Kumordih, PS-Adra, Dist- Purulia along with seized articles (1) One red colour CBZ Motor Cycle bearing Reg. No-JH10P/ 8280, Eng. No-07FBMM01882 and Chassis No-07FBMC01850 along with all connected papers.

I beg to report that today myself along with C/3160 Ranjit Nayek, C /2182 Md. Safiul Khan all of Adra PS were performing special NAKA checking duty at Kalikend · More, Adra under Adra PS area vide Adra PS Misc C.C No-3196/21 dtd.25.08.2021 and Adra PS GDE No-1067. At about 16:50 hrs, I found one motor Cycle bearing Reg. No- JH10P/ 8280 coming from Adra Town side rashly and negligently. We try to stop him but the driver of the said motorcycle named in above was trying to escape the place so rashly, there was every possibility of loss/ serious injury of nearby public due to his such driving. After a hot chase we could able to stop him. On being asked, he stated his name and address as noted above, but unable to give any satisfactory account for his such rush and negligent driving which may cause endanger to human life. On being asked above noted person unable to produce valid driving license before me.

So, I seized the motor cycle and arrested him as he violated sec 279 IPC & 181 MV Act 1988 at about 16:55 hrs with a view to prosecute him U/S 279 IPC & 181 MV Act 1988 in presence of witnesses. The whole process of seizure was completed in between 16:55 hrs to 17:15 hrs. His family member was also informed about the ground of arrest.

Hence I pray that a specific case U/S 279 IPC & 181 MV Act 1988 may kindly be initiated against accused Lalchand Mondal (21 Yrs) S/O Mihir Mondal of Vill-Kumordih, PS-Adra, Dist- Purulia.
