Sir,

In producing here with one arrested accused namely Rohan Chowdhury (40 Yrs) S/O Lt. Ramdhani Chowdhury of Vill-Doulatpur, Majhipara, PS-Adra, Dist- Purulia along with following seized articles with seizure list and Memo of Arrest.

- 1) 05 bottles DIL KHUSH country spirit, 600 Ml. each Rs/-50 of each bottle.
- 2) 20 bottles DIL KHUSH country spirit, 300 Ml. each Rs/-25 of each bottle.

I ASI Krishnapada Gorain of Adra PS do here by lodged a complaint against accused namely Rohan Chowdhury (40 Yrs) S/O Lt. Ramdhani Chowdhury of Vill-Doulatpur, Majhipara, PS-Adra, Dist- Purulia to the effect that on 27/08/21 at about 19:55 hrs I received a information from a reliable source that one Rohan Chowdhury has been stock of country spirit illegally at his house at Daulatpur Majhipara Village during my evening mobile duty vide CC No-3218/21 dtd.27.08.21. After getting such information I along with my accompanied force left for Doulatpur, Majhipara Village, to work out the Information. We reached at Doulatpur, Majhipara Village, at about 20:25 hrs and hold raid in the house of said Rohan Chowdhury and found that the said person selling liquor at his house and after seeing the Police party some person fled away and said Rohan Chowdhury has tried to concealed himself but I able to apprehend him with the help of accompanied force and also detained him. I asked him to produced, valid License or valid papers for selling country spirit but he failed to produce any valid license or documents for possessing /selling the same. So it is sufficient reason to believe that said Rohan Chowdhury selling the country spirit by illegal way. I seized the above mentioned articles under proper seizure list duly sign by accused person and available witnesses and arrested the above mentioned accused person informing the ground of arrest. The complete process was done in between 20.35 hrs to 20.55 hrs.

Hence I there for pray that a specific case may kindly be started against arrested accused Rohan Chowdhury (40 Yrs) S/O Lt. Ramdhani Chowdhury of Vill-Doulatpur, Majhipara, PS-Adra, Dist- Purulia under proper section of law.
