Sir,

In producing here with one arrested accused persons namely (i) Sukumar Kalindi (30 yrs) S/O Kitu Kalindi (ii) Shiromani Gorai (60 yrs) S/O- Lt. Daman Gorai both of vill Beldih, P.S.-Arsha Dist-Purulia along with following seized articles.

- 1) Two white colour plastic container with approx 22 ltrs. of ID liquor.
(Approx 500 ml taken out from of the above container as sample packed with sealing wax)

I, SI Anirban Dutta of Arsha PS do hereby lodge a written complaint against the above noted accused persons to the effect that today i.e 21.08.2021 at about 16.35 hrs. during my special mobile duty receive source information over telephone that the above noted accused persons have been selling ID liquor at Beldih village more near Shib Mandir. On receiving the reliable source information I communicated with O/C Arsha PS over telephone and as per his instruction I along with (i) C/- 160 Mahasin Modal (ii) C/306 Rahuldev Bhunia and (iii) C/- 812Supratim Shil all of SAP 7th BN Camp at Arsha PS rushed to the spot to work out the information vide Arsha PS C.C. No.111/21 dtd. 21.08.2021 and GDE No. 809 Dtd. 21.08.2021. Reaching at Beldih village more near Shib Mandir we fixed-up the spot and found that selling of Id Liquor was going on there and having seen police all customers managed to escape, but we were able to apprehended the above noted accused persons. On demand of showing papers they failed to produce any valid documents in support of selling ID liquor. So I seized all the implicating articles as noted above under a proper seizure list from their exclusive possession in presence of witnesses and properly sealed and labeled duly signed by the accused persons and witnesses among which Approx 500 ml taken out from the above container as sample packed with sealing wax with label. During interrogation they confessed their guilt so, I arrested them after observing all the formalities issuing memo of arrest as they were selling ID liquor illegally.

I therefore pray that a specific case may kindly be started against the accused persons namely (i) Sukumar Kalindi (30 yrs) S/O Kitu Kalindi (ii) Shiromani Gorai (60 yrs) S/O- Lt. Daman Gorai both of vill Beldih, P.S.-Arsha Dist-Purulia under proper section of law.
