In producing here with two arrested accused persons namely (i) Prayag Roy (39 yrs) S/O Lt. Prananath Roy of Gouradag, PS- Arsha, Dist- Purulia (ii) Paresh Ch. Mahato (45 yrs) S/O- Lt. Bauridas Mahato of vill Jhariadih, P.S.-Arsha Dist-Purulia along with following seized articles.

1) Two white colour plastic container with approx 25 ltrs. of ID liquor. (Approx 500 ml taken out from of the above container as sample packed with sealing wax)

I, SI Anirban Dutta of Arsha PS do hereby lodge a written complaint against the above noted accused persons to the effect that today i.e 24.08.2021 at about 18.55 hrs. during my special mobile duty near Nayamore, receive source information over telephone that the above noted accused person have been selling ID liquor at in the tea shop of Prayag Roy S/o- Lt. Prananath Roy at Gouradag more under Arsha PS. On receiving the reliable source information I communicated with O/C Arsha PS over telephone and as per his instruction myself accompany with (i) C/- 1243 Abodh Ch. Mahato of Arsha PS (ii) C/306 Rahuldev Bhunia and (iii) C/- 825 Bhaskar Neogi both of SAP 7th BN Camp at Arsha PS rushed to the spot to work out the information vide Arsha PS C.C. No.1725/21 dtd. 24.08.2021 and GDE No. 937 Dtd. 24.08.2021. Reaching at tea shop of Prayag Roy S/o- Lt. Prananath Roy at Gouradag more we fixed-up the spot and found that selling of Id Liquor was going on there and having seen police all customers managed to escape, but we were able to apprehended the above noted accused persons. On demand of showing papers they failed to produce any valid documents in support of selling ID liquor. So I seized all the implicating articles as noted above under a proper seizure list from their exclusive possession in presence of witnesses and properly sealed and labeled duly signed by the accused persons and witnesses among which Approx 500 ml taken out from the above container as sample packed with sealing wax with label. During interrogation they confessed their guilt so, I arrested them after observing all the formalities issuing memo of arrest as they were selling ID liquor illegally.

I therefore pray that a specific case may kindly be started against the accused persons namely (i) Prayag Roy (39 yrs) S/O Lt. Prananath Roy of Gouradag, PS- Arsha, Dist- Purulia (ii) Paresh Ch. Mahato (45 yrs) S/O- Lt. Bauridas Mahato of vill Jhariadih, P.S.-Arsha Dist-Purulia under proper section of law.
