On 02/08/2021 at about 12:30 P.M. I Sri Swapan Kumar Das, AE & Station Manager, Baghmundi CCC along with 1. Sri Subhasis Mahato, Sr.OE, WBSEDCL 2. Sajal Kumar Mahanty, Sr.OE, WBSEDCL entered the premises of Sri Ratisen Kumar, S/O- Sri Bhuban Kumar of village Ekra, P.S- Bagmundi P.O- Rangadib, Dist- Purulia and found Sri Ratisen Kumar was enjoying electricity unauthorizedly drawing power from the nearest LTOH line of WBSEDCL through PVC wire by means direct hooking to his house premises and connected load found 0.2 KVA. As Sri Ratisen Kumar S/O- Sri Bhuban Kumar committed theft of electric power, So, I seized the following articles after preparing the seizer list in presence of 1.
