On 02/08/2021 at about 12:30 P.M. I Sri Swapan Kumar Das, AE & Station Manager, Bagmundi CCC along with 1. Sri Subhasis Mahato, Sr.OE, WBSEDCL 2. Sajal Kumar Mahanty, Sr.OE, WBSEDCL entered the premises of Sri Ratisen Kumar, S/O- Sri Bhuban Kumar of village Ekra, P.S- Bagmundi P.O- Rangadih, Dist- Purulia and found Sri Ratisen Kumar was enjoying electricity unauthorisedly drawing power from the nearest LTOH line of WBSEDCL through PVC wire by means direct hooking to his house premises and connected load found 0.2 KVA.
