Sindri, Dist- Purulia has committed theft of electricity U/S 135(1) (a) of electricity act 2003 subsequently amendment act 2007.

On 03.08.2021 at about 11 am I Sri Swapan Kumar Das, AE & Station Manager, Baghmundi CCC along with 1. Abdul Hasib, LM
