I do hereby lodge complaint empowered by enabling the electricity act 2003 subsequently the amendment act 2007 to the effect that, Sri Masiulla Ansari S/O- Rahim Ansari of village Sindri, P.S.- Baghmundi P.O- G.B. Sindri Dist- Purulia has committed theft of electricity U/S 135(1) (a) of electricity act 2003 subsequently amendment act 2007.

On 03.08.2021 at about 11.15 AM I Sri Swapan Kumar Das, AE & Station Manager, Baghmundi CCC along with 1. Abdul Hasib, LM 2. Subhasis Mahato, O.E entered the premises of Sri Masiulla Ansari, S/O- Rahim Ansari of village Sindri, P.S- Baghmundi P.O- G.B. Sindri Dist- Purulia and found Sri Masiulla Ansari was enjoying electricity unauthorizedly drawing power from the nearest LTOH line of WBSEDCL through PVC wire by means direct hooking to his house premises and connected load found 0.2 KVA. As Sri Masiulla Ansari S/O- Sri Rahim Ansari committed theft of electric power, So, I seized the following articles after preparing the seizer list in presence of 1. Sri
