I do hereby lodge complaint empowered by enabling the electricity act 2003 subsequently the amendment act 2007 to the effect that, Sri Munsari Ansari S/O- Rahim Ansari of village Sindri, P.S.- Baghmundi P.O- G.B. Sindri Dist- Purulia has committed theft of electricity U/S 135(1) (a) of electricity act 2003 subsequently amendment act 2007.

On 03.08.2021 at about 11.45 AM I Sri Swapan Kumar Das, AE & Station Manager, Baghmundi CCC along with 1. Abdul Hasib, LM
