

Most respectfully sheweth:-

1.--- That the complainant is the legally married wife of Bidhan Kuiry, their marriage were solemnized on 17--06--2020Corresponding to 2nd Ashar 1427 B.S. according to the Hindu rites and customs prevalent in their community in presence of some gentlemen of their locality. The marriage tie in between the complainant and accused No.1 is still subsisting. The parents of the complainant gave ornaments, Godd and Silver, utensils, Saries and others articles, Dressing Table, Freeze, Almirah, Divan, Wrist watch, Cash money of Rs. 2,00,000/-(Rupees Two lakhs) to the accused No.1 at the time of ma marriage as per claimed of the accused persons No.1 to 4. 2.___That after solemnisation of the marriage with the accused No.1, the complainant went to her matrimonial house at Shasha, P.S.Baghmundi, and began to lived there as husband and wife with the accused No.1.Accused No.2 is Father-in-law, accused No.3 is the mother-in-law and accused No. 7 is brother-in-law of the complainant. 3.--- That after marriage the complainant and accused No.1 resided as husband and wife peacefully for about 1 months. But after one month of the marriage the complainant was

subjected to mental and physical torture by the accused persons No.1 to 4.But the complainant as she is a good wife

wife of tolerated all the illtreatment some how and for that several time.

4.---That however the torture upon the complainant continued unabated and she also subject to physical torture not only at the hands of her husband but also in the hands of accused No.2 to 4. She was not given due food and wears, she was assaulted by the accused No.1 to 4 all along without any occasions.

5.---That during stay of the complainant in her matrimonal home the accused No.1 to 4 told the complainant to bring Rs.10,000/- and further Rs.15,000/- from her father. The father of the complainant gave Rs.10,000/- to the accused persons as per their demand. The father and the mother of the Complainant went to the house of the accused No.1 with other witness and told the accused persons to keep the complainant peacefully. But they did not hear their good counselling and became very angry and rebucked their in filthly language and the accused No.1 told loudly that he will marry another girl. The accused No.1 has illicit relation with one village girl.

6.---That finally on 15-05-2021 & the accused persons No.1

to 4 assaulted the complainant with fist and blows, severly

and some times accused No.1 and 4 present her neck in order

to kill her but some how complainant was saved and subsequently



subsequently accused persons drove away from their house t_0 the complainant. Since then the complainant is living in her father's house.

7.---That we the incident was reported to the local Pradhan and also to the Police to Baghmundi P.S. and Jhalda P.S. and as per advice the complainant filed this case before your Honour. That all the accused persons No.1 to 4 are vey dangerous and they have illtreated and tortured the complainant. Moreover they took Rs.10,000/-(Rupees Ten thousand) further as dowry from the complainant and after marriage.

In the circumstances, it is therefore prayed that your Honour will be kind enough to sent this complaint O/C Baghmundi P.S. treating this petition as F.I.R.
