Mukunda Lohar (30 Yrs), S/O-Chaitan Lohar of Vill-Gobindapur, 4. Dipak Mura (27 Yrs), S/O-Lt-Gurpada Mura of Vill-Gosaidih, 5. Pralay Sing Deo (19 Yrs), S/O-Lt-Sanat Sing Deo of Vill-Sindri, 6. Rakesh Mahato (24 Yrs), S/O-Kansa Mahato of Vill-Serengdih, 7. Sambhu Kalindi (23 Yrs), S/O-Lt-Satrughan Kalindi of Vill-Matha, 8. Biswanath Kumar (32 Yrs), S/O-Hiralal Kumar of Vill-Bidri all are of PS-Baghmundi, Dist- Purulia to the effect that on 09.08.2021 while I SI Bangshi Badan Mondal along with force 1) C/53 Debendranath Majhi, 2) C/708 Mrityunjoy Sing Mura both of SAP 11th Bn. Camp at Baghmundi PS, Dist-Purulia were performing special mobile duty vide Baghmundi PS GDE No- 449, Dated- 09.08.2021 & C.C. No- 2344/21, dtd- 09.08.2021. During my special mobile duty when myself along with force reached at Charida More on Baghmundi-Jhalda Main Road in between 19:05 hrs to 19:55 hrs and found above persons were roaming aimlessly at Charida More Area without mask or its alternative. I detained them. On being asked the above noted persons disclosed their identity but could not able to give any satisfactory answer for that movement on road and public place.

As the pandemic period related to COVID-19 is going on and hence to prevent its mass spreading the State Govt. has passed order to wear mask in the public places mandatory and ordered to prosecute the defaulters. The order of West Bengal Govt. is Order No-753/IV-ISS/2M-22/2020, Dtd: 29.07.2021.

As such the above persons violated the order during this pandemic situation duly promulgated by Govt. of West Bengal hence the detained persons is refuses to comply the direction given by the Central Govt. & State Govt. to combat the severity of COVID-19 pandemic after several request. So I arrested them for violating the section of Disaster Management Act 2005 after maintaining all arrest related guidelines and rules.

Hence I pray before you to start a specific case against the above noted persons under proper section of law.
