



  The above named complainant most respectfully
  begs to state as follows;
- That the complainant, accused person and the witness are the permanent residents of Village Ponra within P.S Baghmunidh and within the District of Purulia.
- 2. That the complainant and the witness Nos. 2 and 3 and their predecessors are the owner and title holder of the land bearing R. S. Plot No. 1001 of Mouza Ponra having an area of 1.47 acres which consists of a Big Mango garden, planted and nurtured by the complainant and his other associates. The accused persons and or their other associates have no manner of right, title, interest and much less possession on the said land and its trees.
- 3. That on 29. 05. 2021, the aforesaid accused persons, forming an unlawful assembly and armed with deadly weapons like Tangi (a sharp cutting weapon), Iron rod, Bambo Lathi etc. criminally trespassed into the aforesaid Mango Garden of the Complainant and plucked all the well grown mangoes wagging about 50 quintals and also damaged the maximum mango trees and taken away all the said green mangoes. The complainant and his other co-sharers sustained a loss of Rs. 1, 50, 000/- due to the aforesaid illegal and unethical and criminal act of the accused persons.
- 4. That being informed the complainant and his other family members had been to the spot but as the accused persons were in large in numbers and they were armed with deadly weapons and the attacked upon the property of the complainant was preplaned, the complainant and his family members failed to resists the accused persons with their illegal act.





- 5. That on the very date of incident, the complainant and his family members had been to Bagmundih Police Station and informed the incident to the Police in writing but as on action was taken, the complainant send a Written Complaint by Regd. Post with A/D on 20. 07. 2021 to the O. C of Bagmundih Police Station which was dule delivered by the postal department.
- 6. That the accused persons regularly threatening the complainant and his family members with dire consequences.
- 7. That as the Police did not take any steps upon the accused persons; the complainant filed an application before the Superintendent of Police, Purulia on 28. 07. 2021 but the Police did not take any steps against the accused persons till date as such the Complainant is filing the present petition before the Ld. Court.

It is, therefore, prayed that your Honour may be graciously pleased to forward this petition to the Officer-in-Charge of Bagmudih Police Station to start a case against the accused persons named above and asked to submit report before this Ld. Court.
