In producing herewith 08 arrested accused persons namely (1) Laxmikanta Kisku (38 yrs) S/O- Bipinbihari Kisku of Vill-Chipidih (Madhupur), (2) Siron Baskey (18 yrs) S/O-Annanda Baskey of Vill-Rithugora, (3) Jagannath Mahato (36 yrs) S/O-Lt. Badal Mahato of Vill-Madhupur, (4) Nirmal Kumbhakar (32 yrs) S/O-Chakradhar Kumbhakar of Vill-Latapara all of PS-Bandwan, Dist-Purulia (5) Ujjwal Adhikary (33 yrs) S/O- Nripen Ch. Adhikary of Vill-Moudasoli, PS-Dhalbhungar, Dist-East Singhbhum JH (6) Jayanta Sardar (21 yrs) S/O-Mahaendra Sardar of Vill-Bhulaveda, Pataghar, PS-Belpahari, Dist-Jhargram (7) Kartick Mahapatra (25 yrs) S/O-Nilkanta Mahapatra ed VII-Bamuniabandh, PS+Dist-Jhargram (8) Bikash Mahato (21 yrs) S/O-Mittan Mahato of Vill-Maisumara, PS-Barikul, Dist-Bankura. I beg to state that today (01.08.21), I was directed to find out whether wearing of mask by the public has been properly maintained at Bandwan Chwak Bazar or not and also to observe Lock down protocol at night from 09.00 PM to 05.00 AM. Accordingly, I along with (1) C/389 Subir Kundu (2) C/2850 Chiranjit Mondal both of Bandwan PS, Dist-Purulia had been to Bandwan Chwak Bazar at about 21:25 hrs and found that a gathering appeared at Bandwan Chwak Bazar, none of them were wearing mask. On seeing Police they tried to escape from the grip of police party but some failed to escape due to efficient effort of Police. On being asked they disclosed their identity as noted above.

In this pandemic situation of CORONA Virus/COVID-19 the above noted persons violated the order duly promulgated by government through public servants and through media by strolling, riding without mask instead of following the COVID rules of wearing mask and not to stroll after 09.00 PM as there is complete lockdown after 09.00 PM to 05.00 AM. They are creating annoyance in that locality & violated Govt. order No. 753/IV-ISS/2M-22/2020, Dtd-29/07/21 for complete restriction measure. So, I arrested them for Disobedience of order duly promulgated by public servant after maintaining all rules of arrest, Issued memo of arrest. I informed them & their relatives regarding the ground of arrest i.e. as per section 3 of the Epidemic Diseases Act, 1897, provide penalties for disobeying any regulation or order made under the Act and released them on bail. At prima facie there were sufficient evidences to secure their detention. All the process was done in between 21:35 hrs to 22:00 hrs.

Therefore, I pray a specific case may kindly be lodge against above noted arrested accused persons as they disobeyed Govt. order and committed negligent Act likely to spread infection of diseases dangerous to lie and violated
