In producing herewith 07 arrested accused persons namely (1) Rajib Murmu (23Y) S/O-Sadhu Murmu of Vill-Pargela, (2) Ram Ch. Gorai (39Y) S/O-Purnachandra Gorai of Vill-Dhadka both of PS-Bandwan, Dist-Purulia (3) Pradip Mahato (25Y) S/O-Ashok Mahato of Vill-Charak Pahari (4) Bishnupada Soren (29Y) S/O-Bistu Soren of Vill-Diashi both of PS-Belpahari, Dist-Jhargram (5) Prasanta Kr. Mahato (42Y) S/O-Mansaram Mahato of Vill-Laldungri, PS-Boro, Dist-Purulia (6) Gopal Kumar (25Y) S/O-Dhaturi Saw of Vill-Bhagatdih, PS-Jharia, Dist-Dhanbad (7) Sahadeb Murmu (35Y) S/O-Nimay Murmu of Vill-Dhadkidih, PS-Patamda, Dist-East Singbhum, Jharkhand. I beg to state that today (22.08.21), I was directed to find out whether wearing of mask by the public has been properly maintained at Bandwan Chwak Bazar or not and also to observe Lock down protocol at night from 11.00 PM to 05.00 AM. Accordingly, Lalong with (1) C/1139 Jiban Senapati (2) C/600 Amit Shit both of Bandwan PS, Dist-Purulia had been to Bandwan Chwak Bazar at about 23:25 hrs and found that a gathering appeared at Bandwan Chwak Bazar, none of them were wearing mask. On seeing Police they tried to escape from the grip of police party but some failed to escape due to efficient effort of Police. On being asked they disclosed their identity as noted above.

In this pandemic situation of CORONA Virus/COVID-19 the above noted persons violated the order duly promulgated by government through public servants and through media by strolling, riding without mask instead of following the COVID rules of wearing mask and not to stroll after 09.00 PM as there is complete lockdown after 11.00 PM to 05.00 AM. They are creating annoyance in that locality & violated Govt. order No. 753/V-ISS/2M-22/2020, Dtd-13/08/21 for complete restriction measure. So, I arrested them for Disobedience of order duly promulgated by public servant after maintaining all rules of arrest, Issued memo of arrest. I informed them & their relatives regurring the ground of arrest i.e. as per section 3 of the Epidemic Diseases Act, 1897, provide penalties for disobeying any regulation or order made under the Act and released them on bail. At prima facie there were sufficient evidences to secure their detention. All the process was done in between 23:30 hrs to 23:55 hrs.

Therefore, I pray a specific case may kindly be lodge against above noted arrested accused persons as they disobeyed Govt. order and committed negligent Act likely to spread infection of diseases dangerous to lie and violated the rule.
