








The humble petition on behalf of the complainant / Petitioner named above

- 1. That ,the Complainant happens to be a permanent resident of Village Tokoria, P.O Tokoria, P.S Barabazar, within this district having his hearth and home thereat.

That while on 09/07/2019 at about 4.00 P.M when Complainant's namely Barsarani Mahato returning home from school one vehicle (Bolero Pickup) bearing No Registration No WB55A 9452 comes from Purulia side and the driver of the vehicle runs the vehicle in rash and negligent manner dashed the complainant's daughter near tokoria more and the complainant's daughter fell on the ground.

- 6. That the accused persons have committed several offences of the Indian Panel Code which warrant police investigation into the case
