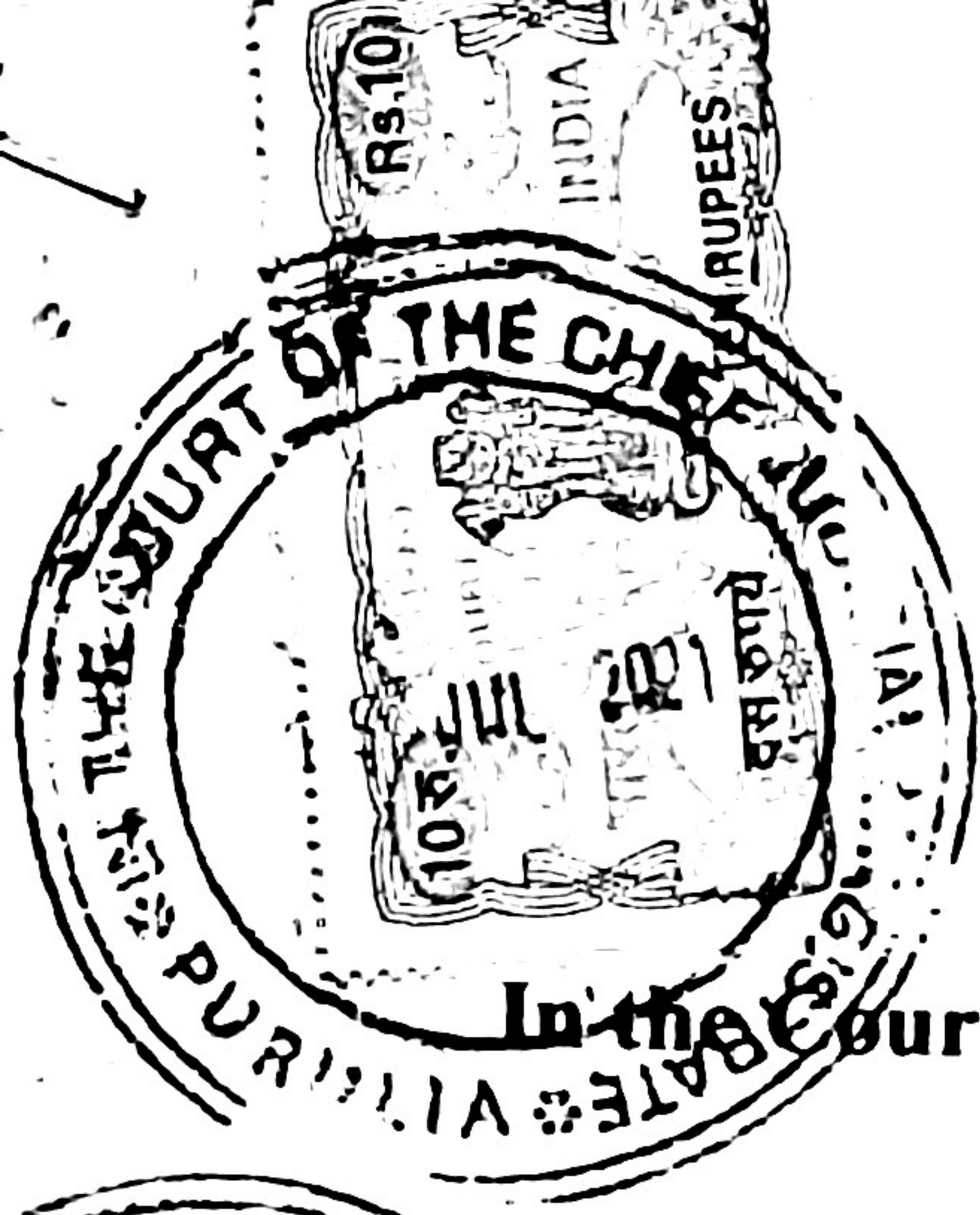

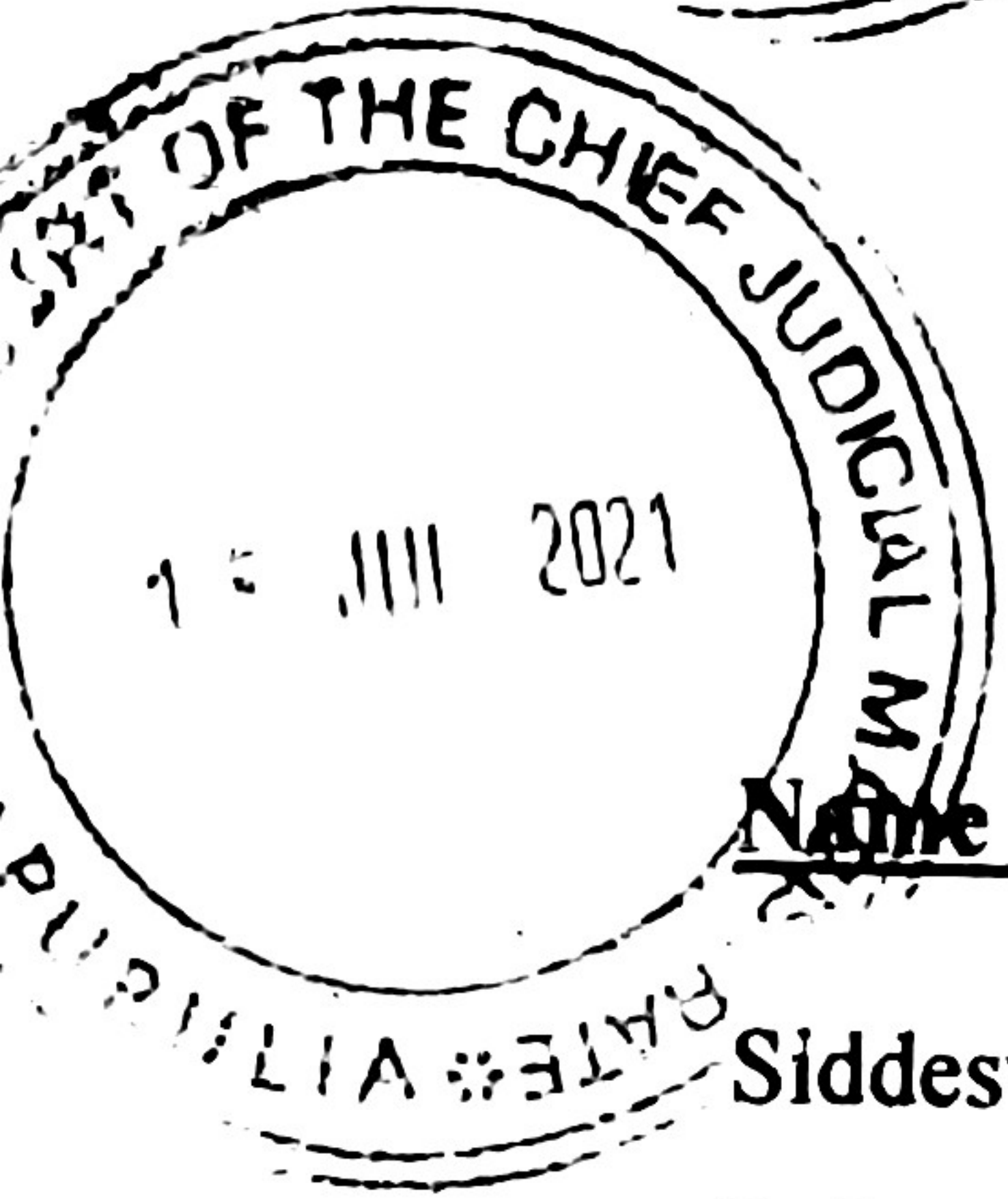

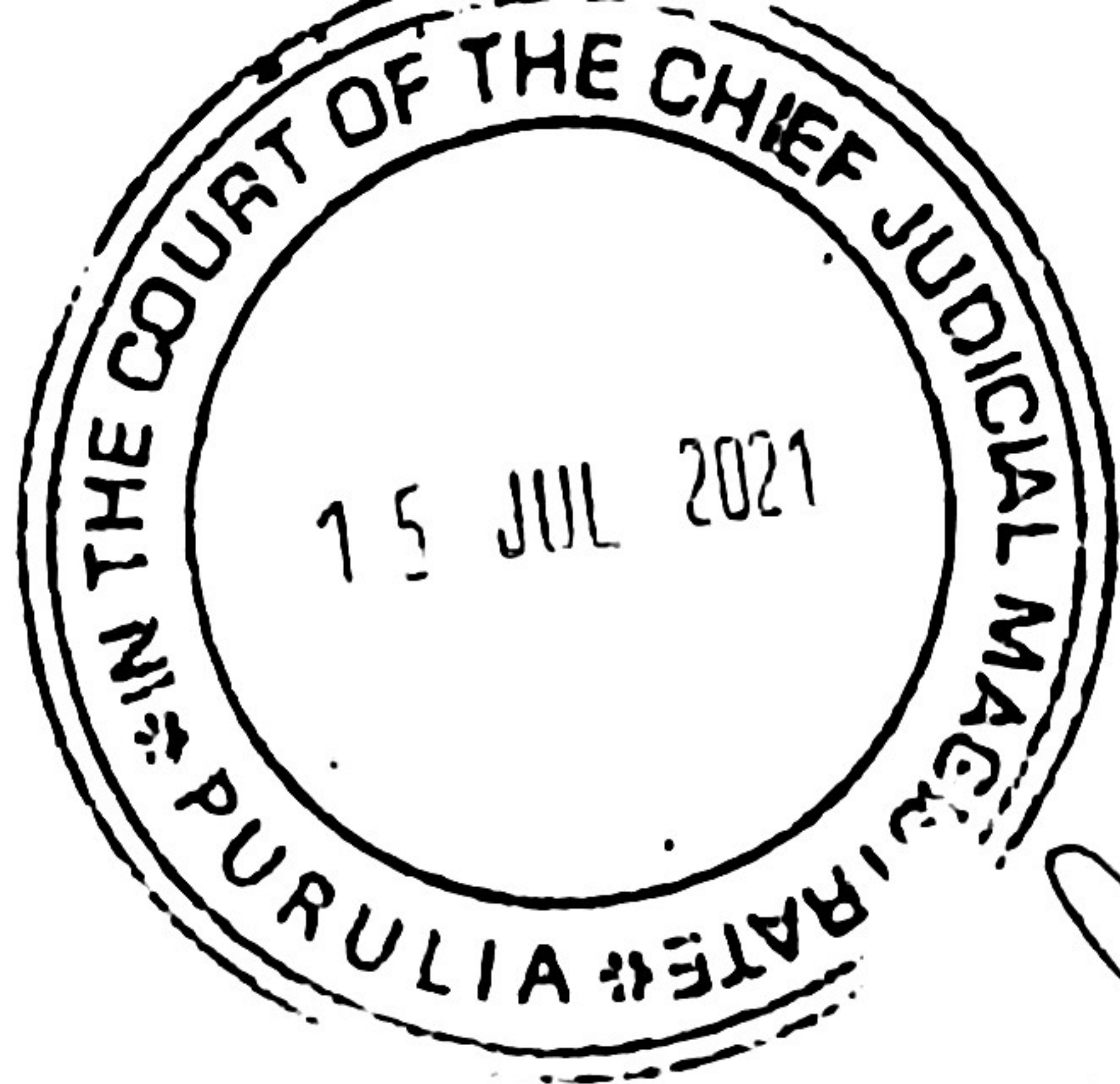

Most respectfully sheweth :

1. That ,the Complainant happens to be a permanent resident of Village – Tokoria , P.O – Tokoria, P.S – Barabazar, within this district having his hearth and home thereat.
2. That while on 09/07/2019 at about 4.00 P.M when Complainant's namely Barsarani Mahato returning home from school one vehicle (Bolero Pickup) bearing No Registration No – WB55A 9452 comes from Purulia side and the driver of the vehicle runs the vehicle in rash and negligent manner dashed the complainant's daughter near tokoria more and the complainant's daughter fell on the ground.
3. That the local person who were nearby the tokoria more rushed and took the complainant's daughter to Deban Mahato sadar Hospital and the aforementioned Hospital referred the complaint's daughter to Higher medical centre for better treatment .
4. That Complainant admitted his daughter at Tata Main Hospital for better treatment.
5. That after treatment Barsarani Mahato and got release from the Hospital ,on the same day the complainant had been to the Barabazar P.S and the complainant narrated the matter before officer on duty of Barabazar P.S and the same was reduced in writing and was submitted to the Police officer of Barabazar P.S but as no action had been taken against the accused and again the same written complaint has been sent through registered post on 1/07/2021 but no case has been initiated against the accused till 06/07/2021 and your Petitioner intimated the matter in writing to the Superintendent of Police, Purulia on 06/07/2021 but that too failed to evoke any response.
6. That the accused persons have committed several offences of the Indian Panel Code which warrant police investigation into the case
