Sub: Prayer for lodging F.I.R.

Sir.

In producing herewith the arrested accused Afzal Ansary @ Sk Afjal S/o- AYES Lt. @ Mujaffar Mahammad of Village- Raigara, PS- Barabazar, Dist- Purulia and Abu Taher MIR @ Abu Tar S/o Monu Mir of DO and beg to report that on 08.08.2021 at about 19:05 Hrs I received a source information regarding presence of the above noted proclaimed accused person in his house at TATA, JAMSHEDPUR. Accordingly I informed the matter to I/C Barabzar PS and diarized the fact in GD vide GD no 424 dt 08/08/2021. Accordingly IC Barabzar did all the formalities of informing supirrior officers and obtaining permission.

As per direction of I/C BZR PS, I along with i) SI Mithun Kr. Sar ii) ASI Manas Kr. Pa iii) C/- 963 Sourav Santra iv) C/- 971 Amit Manna Hembram v) C/- 1009 Tanmoy Ghosh vi) C/- 1003 Tapan Mallick vii) LC/-3076 Rupali Sing Malla viii)C/1147 Bappaditya Nandi; left for village Damdubi and Taj nagar, PS:- Chandil, Jamshedpur, to work out the source input vide Barabzar PS CC No. 1641/21 Date – 08.08.2021 at about 21:25 Hrs. we used vehicle no WB 20 U 3393 and JH 05 BV 6176. We reached at KAPALI O.P under Chandil SP around 23.05 hrs abd submitted requisition for raid and assistance. After that we left for the places of raid.

On arrival at about 00:55 hrs I along with force reached at TAJ Nagar and cordoned the house of Abu Taher Mir as per source information. It was the rented house of one Dr Basir. Subsequently held raid against the said accused person and managed to apprehend him. On interrogation he confessed that he had every knowledge regarding proclamation and attachment completed against him but knowingly he was avoiding court order by remaining absconding. Accordingly I arrested him (at about 02.05 hrs) by preparing proper memo of arrest observing all legal formalities for violating order issued by the Ld. Court. I searched him but found nothing except his wearing apparels. I informed his family members. After that myself and team left for Damdubi village in order to apprehend Afzal Ansary as per source information. At about 02.25 hrs we reached at the house of Afzal Ansry at Damdubí. We cordoned the house and observed formalities. Subsequently held raid against the said accused person and managed to apprehend him. On interrogation he confessed that he had every knowledge regarding proclamation and attachment completed against him but knowingly he was avoiding court order by remaining absconding. Accordingly I arrested him (at about 02.45 hrs) by preparing proper memo of arrest observing all legal formalities for violating order issued by the Ld. Court. I searched him but found nothing except his wearing apparels. I informed his family members.

As per order of Ld. Court and proclamation order had been served against them as follows:-

For Abu Taher Mir; On 06/09/16 vide GDE No. 309 Date- 06/09/16 and the process of attachment has been completed on 16/30/16 in presence of witnesses nil S/L was prepared. Though proclamation was served against the above noted accused person but he knowingly disobeyed the order of Ld. Court.

For Afjal Ansari @ Sk Afjal; On 09/03/16 vide GDE No. 498 Date- 09/03/16 and the process of attachment has been completed on 11/04/16 in presence of witnesses nil S/L was prepared. Though proclamation was served against the above noted accused person but he knowingly disobeyed the order of Ld. Court.

Under the above circumstance, I pray that a specific case U/S- 174A IPC may kindly be initiated against the above noted 02 accused persons for non-appearance in response to proclamation against them U/S-82 of Act 2 of 1974 in c/w above referred cases.
