Sub: Prayer for lodged FIR.

Sir,

In producing here with 02 (Two) tractors attached with trolleys respectively, bearing Registration No- JH 05BC 0368 (written in the trolley) and another number 391354STB02617A written on body (as read in naked eye) loaded with sand about 100 C.ft (Approx) and another tractor bearing Engine No- 31005LLQ4H952296F18 and Chassis No- JZJSH956611S3 (as read in naked eye) loaded with sand about 100 C.ft (Approx) Seizure lists, Alamat and sample of Alamat as exhibit 'A' & 'B'.

I beg to state that on 21.08.2021 myself along with C/- 357 Gopal Biswas and C/-98 Anil Ch. Orang performing evening mobile duty vide C.C No- 1796/2021 Dtd. 21.08.2021 and GDE No-1167 Dtd. 21.08.2021 with Govt vehicle bearing Registration No- WB 26K 5475. I reached Amrabera more at about 21.05 hrs as per source information and direction received from Duty officer ASI Sadhan Ch. Danda, After arriving there got further information from source about transportation of sand with intent to sell to other destinations by illegal means from Manbazar sides and going towards Barabazar/Purulia under this district jurisdiction.

I conveyed the same to I.C Barabazar PS again and as per his direction myself along with force started NAKA checking at Amrabera mor from 21.10 hrs. At about 21.25 hrs 02 tractors having details as noted above loaded with sand were coming toward the Naka point and seeing the Police party the drivers fled away after keeping the tractors beside the Amrabera road. Chased him but somehow they managed to escape under the cover of darkness. Seized both the tractors attached with trolleys loaded with sand about 100 C.ft approx in each trolleys. Details of the tractors are the same as noted above.

Held an enquiry about the matter and so far information collected it is crystal clear that the drivers and the owners of the vehicles collected the sand by illegal means with intent to make unlawful profit by unlawful collection of sand through illegal manner by unauthorized extraction and removal of mines & minerals. By this way they violated the regulation of procurement of minor minerals. As such there is every reason to believe that the drivers and owners of the said tractors with ill motive were transporting the sand illegally without any valid document in support of carrying sand. They violated the Govt. order of not extracting sand from the river. As such they were doing illegal business activities.

Under the above facts and circumstances, I pray before you that kindly take needful action against the drivers and owners of said tractors.
