I do hereby lodge complaint, empowered by enabling "The Electricity Act, 2003" subsequently electricity act-2007 to the effect that RAHIN SINGH SARDAR S/O Lt. SHIBU SINGH SARDAR of VIII- TURANGDIH, P.S- Barabazar, Dist- Purulia, his family was enjoying electricity illegally by hooking from nearest LT OH line with the help two core Flexible wire and he has committed theft of electricity U/S 135(1)/a of the electricity (Amendment act-2007).

On 25.08.2021, I Sri BANTI KARMAKAR, A.E. & S.M., BARABAZAR CCC, WBSEDCL along with

- (1) SHIBAJI CHAKRABORTY, J.E GR II(E), BARABAZAR CCC, WBSEDCL
- (2) MD QASIM ANSARI, O.E., BARABAZAR CCC, WBSEDCL

At About 12:02 P.M., entered into the premises of RAHIN SINGH SARDAR S/O Lt. SHIBU SINGH SARDAR of VIII- TURANGDIH, P.S- Barabazar, Dist- Purulia and Inspected his premises at VIII- TURANGDIH, P.S Barabazar, DIST- Purulia.

During inspection, It was found that RAHIN SINGH SARDAR S/O Lt.
