Brief fact of the case :-

1) That on 14/05/2021 at about 5:00 p.m. the complainant had been to their pond named as Puratan Band to attend the nature's call and while the complainant just to return to his house after meeting his nature's call all on a sudden the accused person apprehended one complainant having armed with Lathi, in their hands and started assaulting the complainant. The complainant on his person and the complainant fell down on the ground and the accused persons continued to assault the complainant by the lathis legs and Back and even for getting the head the complainant sustained bleeding injuries on his legs and back and on hearing cry of the complainant the other accused persons came to the spot and the accused persons fled away.

2) That the complainant had been brought to Barabazar B.P.H.C. when however treated by the attending Doctors.

3) That the complainant informed the matter to the I.C. Barabazar P.S. on 15/05/2021 but did not take yet any steps against the accused persons. The accused persons are moving freely in locality and threatening the complainant to assault again and to murder the complainant informed the matter to the S.P., Purulia on 25/07/2021 but of no result as such the complainant files this petition for taking action
