In producing herewith, the 13 (Thirteen) persons, namely (1) Dharam Raj Kumar (20) S/o Sushen Kumar of village Bhurshu, PO-Koreng, PS-Bagmundi, Dist-Purulia. (2) Samiul Sk (35) S/o Rabbani Sk of village Hutmura, PS-Purulia (M), Dist-Purulia. (3) Madhab Nayak (21) S/o Giridhari Nayak of village Sarjumahatu Tola Mahuldih, PS-Jhalda, Dist-Purulia. (4) Basuri Kumar (28) S/o Hanu Kumar of village Chekya, PS-Kotshila, Dist-Purulia. (5) Prasad Kumar (33) S/o Bhuban Kumar of Do. (6) Madhab Kumar (32) S/o Bhuban Kumar of Do. (7) Dhanapati Mahato (30) S/o Manoranjan Mahato of village Mashina, PS-Jhalda, Dist-Purulia. (8) Muruli Mahato (57) S/o Late Matharam Mahato of Do. (9) Hemanta Kumar (35) S/o Kishanlal Kumar of Do. The fact of the case in a nut shell is that today i.e. on 02/08/2021, I SI Jayanta Kr. Chakraborty along with force namely (i) C/2208 Abhijit Duley, (ii) C/2801 Tridip Sahu and (iii) JC/1464 Montosh Bhagat all of Tulin OP were performing mobile duty as well as Naka duty at Mashina more on Jhalda-Ranchi road from 21:05 hrs for the implementation of the Govt. Order regarding all to wear Mask. This refers to Tulin OP under Jhalda PS GDE No 51 dtd. 02.08.2021 in consonance with C.C No 1007/21 Dtd. 02.08.2021. During the Naka duty at Mashina More, I intercepted the following above noted 13 (Thirteen) persons noted in the supra (Sl no 1-13), who were loitering aimlessly and passing Mashina More without wearing the mask and not maintaining the lock down order passed by Govt. of West Bengal from 21:00 hrs to 05:00 hrs. On being asked they could not give sufficient reason or satisfactory answer of their unwarranted loitering after violating the Government Order in this pandemic situation. Consequently, it reasoned to believe that they violated the order and disobeyed the direction during this pandemic situation duly promulgated by Govt. of West Bengal vide Memo No 753-ISS/2M-22/2020 dtd 14/06/2021, Memo No 486-CS/2021 dtd 24/04/2021, Memo No-647-ISS/2M-22/2020 dtd 15/05/2021, Memo No 753/II-ISS/2M-22/20 dtd. 28.06.21, Memo No 753/III-ISS/2M-22/2020 dtd. 14.07.21 and Memo No. 753/IV-ISS/2M-22/2020 dtd. 29.07.21. Consequently, the supra noted persons were arrested on the spot and informed them the ground of their arrest and issued memo of arrest in respect of them.

As the supra noted persons violated the order and disobeyed the direction during this pandemic situation duly promulgated by Govt. of West Bengal vide Memo Nos noted above. Ergo, they can be booked U/S 188 of the IPC and 51 (1) (b) of the Disaster Management Act 2005 and read with section 3 of the Epidemic Diseases Act, 1897. Ergo a specific case may kindly be initiated against them and arranged for its investigation.
