Sir, *on date 03.08.2021 at around 9:30 AM.*

This is to inform you that while performing plantation work at Mouza Uhatu JL. No. 100, Plots No.1468, 1474 G.P.- Mathari Khamar, P.S-Jhalda some miscreants Name Krishnapada Mahato S/O Deben Mahato Village-Burudih ,P.O-Burda , P.S- Baghmundih and his son Rajesh Mahato S/O Krishnapada Mahato along with some local people obstructed our work and claiming some patches of land forcefully without any and paper and documents. They not only obstruct our plantation work but also made threat to life of our staffs and FPC (Forest Protection Committee) members along with weapons like Kukri, axe and handmade revolver, *pushed the staffs from the land away.*

After receiving the information I along with my other staffs reached the spot but the culprit threatened the undersigned also for life and for dire consequences to all the staffs. In this circumstance I request you to do necessary actions from your end so that the plantation drive work at Uhatu shall be completed without any hindrances.

A copy of complaint from Uhatu FPC (Forest Protection Committee) has also been enclosed herewith.
