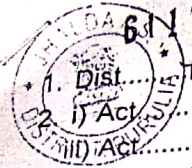

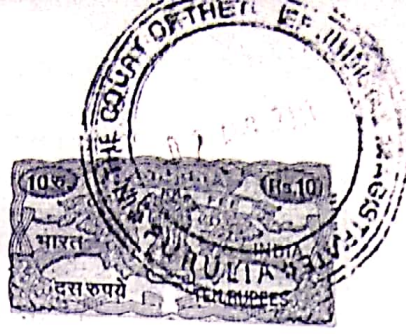

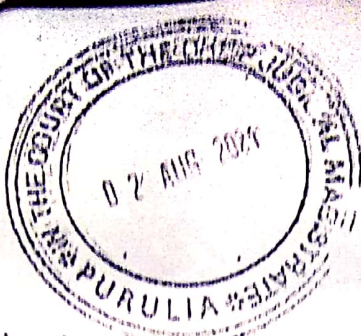

The humble submission on behalf of the Complainant
Most respectfully beg to State :

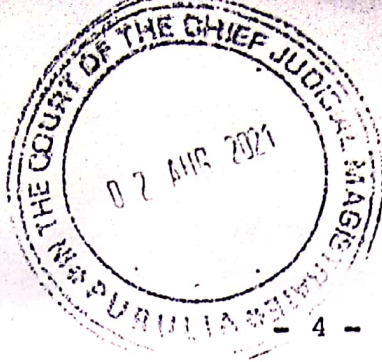
- 1) That both the parties are the residents under Jhalda Police Station area which is under your Jurisdiction.
- 2) That during some days, the complainant came to learn from others that all the accused persons, have been spreading a rumour within the area that i) Parbati Laya, W/o. The complainant, ii) Ranjit Laya, brother of your petitioner and iii) Gouri Laya W/o. Ranjit Laya as witch (Dayen) and whispering and making conspiracy to burn alive all the family members of the complainant and in such a way the accused persons were some how success in making the family of the complainant as everybodies target.
- 3) That on 12/07/2021 at about 9.00 p.m. in the Night all the accused persons, with Lethal weapon like Farsa, Tangi, Shawals, Bamboo sticks forcibly break open the door of the house of the complainant and attacked them all.
- 4) That after beating the family members of the complainant, i.e. all the witnesses and forced them at the point of Tangi, Farsha to come outside of the house and took them to the open land near a matured Mehagani tree.
- 5) That then all the accused persons ordered the complainant and others to cut the tree immediately as they declared the tree as the shelter of witch and Bhoot.
- 6) That the complainant request them to spare the matured and costly Mehgoni Tree as they Nurished the tree to meet future requirment of money, but nobody paid any attention to the request and forced them to cut the tree immediately to save their life.

- 7) That finding no other way and to save the life of the family member from the accused persons in the lonely and Dark place, all the members of the complainant, than being compelled cut-down the tree.
- 8) That after this incident the accused persons directed your petitioner and his other family member to leave the village at once, otherwise, they declare that if the complainant do not leave the village with all, they would not hesitate to burn them alive declaring them as witch and harmful to the village.
- 9) That finding no way they left the village in the night and trasfered the house wives to their respective father's house and the complainant with other male member have been moving as vagabonds keeping their livestocks at the house without anybodies care.
- 10) That ~~xxxx~~ the complainant set-up his mind and after consultation with brothers and some welwisher, reached Jhalda Police station with a written complain on 16/07/2021
- 11) That beyond the Imagination, the duty officer did not hear them and put the complain in the drawer without reading it and ordered the complainant to make settlement of the incident or to come next day.
- 12) That when the complainant again presented himself in the police station, the very duty officer told him that everything has been settled and assured him that the accused persons will not do any harm to them and also said that the accused person has beg excuse by acknowledging their misdeed in written before the thana. That your petitioner than requested the duty officer to givehim a xerox copy of that "MAFINAMA"

assaid by him, than the officer was ^{excited} and told your complainant to leave the place.

13) That finding no way your petitioner than sent the complain to the I.C., Jhalda P.S. on 22/07/2021, by registered post but not to effect.

14) That your petitioner then filed a complain before the S.P., Purulia duly received by the office on 26/07/2021, but to no effect.

15) That all the accused persons with joint hand and with a common intension have committed offence by beating us, by giving pressure to cut down costly tree, to hackle all the family members by defaming them as witch, by making all the members of the family of the complainant a easy target of being murdered, by forcibly throwing them from the village under life threat keeping the live-stocks at house without any bodies care.

16) That till date, the complainant and others are under panic and unable to enter the village having no support from the police.

In these position it is therefore prayed that your Honour would graciously be pleased to send this petition to the I.C., Jhalda Police Station giving order to treat this petition as F.I.R. and to start a case against the accused persons as contemplated under section 156(3) Cr.p.c.
