The fact of the case in a nut shell is that today i.e. on 09/08/2021, I SI Jayanta Kr. Chakraborty along with force namely (i) C/2801 TridipSahu, (ii) C/2065 GopalBisui and (iii) HG/1722 SripatiMandal, all of Tulin OP were performing mobile duty as well as Naka duty at Maru more on Jhalda-Ranchi road from 21:05hrs for the implementation of the Govt. Order regarding all to wear Mask and not to move unnecessarily during lockdown period from 21:00 hrs to 05:00 hrs. This refers to Tulin OP under Jhalda PS GDE No 244 dtd. 09.08.2021 in consonance with C.C No 1041/21 Dtd. 09.08.2021. During the Naka duty at Maru More, I intercepted the following above noted 11 (eleven) persons noted in the supra (SI no 1-11), who were loitering aimlessly and passing Maru More without wearing the mask and not maintaining the lock down order passed by Govt. of West Bengal. On being asked they could not give sufficient reason or satisfactory answer of their unwarranted loitering after violating the Government Order in this pandemic situation. Consequently, it reasoned to believe that they violated the order and disobeyed the direction during this pandemic situation duly promulgated by Govt. of West Bengal vide Memo No 753-ISS/2M-22/2020 dtd 14/06/2021, Memo No 486-CS/2021 dtd 24/04/2021, Memo No-647-ISS/2M-22/2020 dtd 15/05/2021, Memo No 753/II-ISS/2M-22/20 dtd. 28.06.21, Memo No 753/III-ISS/2M-22/2020 dtd. 14.07.21 and Memo No. 753/IV-ISS/2M-22/2020 dtd. 29.07.21. Consequently, the supra noted persons were arrested on the spot and informed them the ground of their arrest and issued memo of arrest in respect of them.

As the supra noted persons violated the order and disobeyed the direction during this pandemic situation duly promulgated by Govt. of West Bengal vide Memo Nos noted above, Ergo, they can be booked U/S 188 of the IPC and 51 (1) (b) of the Disaster Management Act 2005 and read with section 3 of the Epidemic Diseases Act, 1897. Ergo a specific case may kindly be initiated against them and arranged for its investigation.
