Sub: Lodging FIR

Sir,

In producing here with the arrested Accused person namely Jagabandhu Mahato (50) S/o Late Lallu Narayan Mahato of VIII- Kavita, PS- Jhalda, Dist- Purulia as disclosed by the arrested accused person along with seized articles under proper seizure list (enclosed here with) i.e. (i) One Black colored Motor Cycle Hero HP Deluxe having Registration No WB 56P/0471 in consonance with Engine No H/ALHP9K12702 and Chassis No MBI HAR 23819K04327 (ii) One Yellow colored nylon bag (iii) Exhibit Mark 'A' i.e. one transparent plastic Jaricane along with deep brown colored cap containing 4519 grams (including Jars) of light red colored codeine mixture (from which mother sampled 4 bottles of 100 grams each taken out for test samples and security samples marked as Exhibit 'B1' & 'B2' & 'C1' & 'C2'), (iv) Exhibit mark - 'B1' & 'B2' containing 112 grams each of codeine as test sample (including bottle), (v) Exhibit mark 'C1' & 'C2' containing 112 grams each of codeine as security sample (including bottle). All Exhibits are in properly sealed and labeled condition under proper seizure list.

I SI Milon Manna of Jhalda P.S. do herewith lodge a complaint against the above noted accused person to the effect that on 21.08.21 at 23:25 hrs. Duty officer of Jhalda PS ASI Sudip Mukhopadhyay received a telephonic information from an unknown caller that two persons riding in a Motor Cycle with a yellow colored nylon bag loaded with illegal narcotic substance (codeine) would come from Jharkhand state within an hour at Mahatomara PHC to supply the same to its buyer. The matter was diarised vide Jhalda P.S. GDE No- 994 Dt- 21.08.21 and at once the information brought to the notice of my immediate superior i.e. I/C Jhalda P.S. who immediately endorsed the matter to me to work out the tip off. Subsequently, as per direction of I/C Jhalda P.S myself along with (i) ASI- SK Abdul Jamshed (ii) C/197 Ambuj Kumar Mandal (iii) C/1496 Subal Chandra Mahato (iv) C/682 Mahadeb Rajak (v) PD/101 Sambhu Charan Murmu all are Jhalda P.S. at once left for Mahatomara PHC to work out the information with Govt. Vehicle No WB 56C 8741 and command certificate no 3231 Dt- 21.08.21 in consonance with Jhalda P.S GDE No- 995 Dt- 21.08.21 along with weighing machine (Collected from Radhanath Kumar S/O Gokul Ch Kumar of Badhaghat, Ward No- 7, PS- Jhalda, Dist- Purulia) investigation kit and other necessary inventory items of mandatory articles like white papers, carbon papers, brown papers, pen, rubber, stamp with pad, electronic weight machine (ranging from 10 grms to 5 Kgs.), sealing wax, brass seal, candle, match box, thread, gum, sample & sample security empty bottles 4pes after preparing inventory list. We reached in front of Mahatomara PHC at 00:15 hrs and we tried to accompany with any public witness but due to the dead night no public witness was available with us .Subsequently, we waited there for twenty minutes and placed the barricade properly then we noticed two persons riding on a motor cycle were approaching towards Mahatomara PHC from kalma village side hanging with a yellow colored nylon bag loaded with some articles on 22.08.21 at 00:35 hrs. On getting the smell of Police, they tried to flee away from there but we were capable of detaining the motorcycle rider though one person was managed to flee away with one bottle in his hand. Consequently, we disclosed our identity before him and being asked he disclosed his identity as noted above and we informed him that we had specific information that he had illegal narcotic substance (codeine) with him inside the nylon bag and issued notice informing him that as per NDPS Act, the search process may be conducted by any Executive Magistrate or any Gazetted officer according to his wish. He informed me that he wanted to search himself by an Executive Magistrate, Accordingly as per his wish I requested I/C Jhalda PS over telephone to arrange for an Executive Magistrate for the said search process.

At about 01:15 hrs I/C Jhalda PS informed me over telephone that no Executive Magistrate could be made available at such odd hours of night. I informed him and issued another notice that SDPO Jhalda is a Gazetted
