In producing here with 01 (one) arrested accused person namely Karna Mandal (22) S/O Ananda Mandal of vill- Kudlung, PO- Ekra, PS- Bagmundi, Dist.- Purulia and brought under seizure i) 01 (one) Motor Cycle Honda CD Twister having Reg. No-WB56F-5188 and ii) 01 (one) colourful rear bag iii) 01 (One) plastic packet containing approx 20 (Twenty) Ltrs. ID liquor (Chhullu) which was found inside Sl. No-ii, iv) 500 ml was taken out in a plastic bottle from the mother sample noted in Sl. No-iii as test sample from his possession.

The fact of the case in a nutshell is that today 22/08/21 I along with force was performing evening mobile duty vide C.C. No-3239/2021 date 22/08/2021 in consonance with Jhalda PS GDE No-1020 dated-22/08/21 during my evening mobile duty I received a telephonic source information that one person is carrying I.D. liquor (Chhullu) from Bagmundi PS area by riding on a motor cycle and coming towards Ichag village for selling ID liquor at Ichag village . Immediately I informed the matter to I/C Jhalda P.S over phone and as per his direction myself along with force C/386-Sibendu Sinha, C/661-Jitendranath Pathak ,NVF/039-Lalit Kishore Mahato and HG/1829 Subodh Ch. Mahato proceeded to work out the said information. We reached near Jargo more on Jhalda Bagmundi pitch road at about 18:45 hrs. and started NAKA checking by placing guard rail and at 18:55 hrs. we found 01 (one) person coming from Bagmundi side towards Ichag in one Motor cycle. We stopped him and found 01 (One) plastic packet containing approx 20 (Twenty) Ltrs. ID liquor (Chhullu) which was found inside a colourful rear bag in his Motor cycle. I asked him to produce licence or any valid document in respect of ID liquor. But he failed to produce any valid document in respect of said ID liquor. During interrogation he disclosed his identity as noted above and confessed that he made those ID liquor at Kudlung Village and would sell at Ichag village to the villagers in exchange of money. Accordingly I seized i) 01 (one) Motor Cycle Honda CD Twister having Reg. No-WB56F-5188 and ii) 01 (one) colourful rear bag iii) 01 (One) plastic packet containing approx 20 (Twenty) Ltrs. ID liquor (Chhullu) which was found inside Sl. No-ii, iv) 500 ml was taken out in a plastic bottle from the mother sample noted in Sl. No-iii as test sample under proper seizure list duly signed by the witnesses as well as accd. person with proper label. I search for local witnesses but none is there. I arrested him maintaining all formalities of arrest.

On return to PS along with accd. person and all seizure articles. Put the accd. person in the Lockup after maintaining all formalities and seized articles kept in PS Malkhana and I pray a specific case may kindly be lodged against Karna Mandal (22) S/O Ananda Mandal of vill- Kudlung, PO- Ekra, PS-Bagmundi, Dist.- Purulia and arrange for investigation.

L.S.I. of Police. Jhalda P.S. Dist- Purulia. Officer and if he agrees SDPO Jhalda can conduct the said search process and obtaining his written consent, I intimated SDPO Jhalda to remain present to supervise the search process.

Around 01:35 hrs Shri Subrata Deb SDPO Jhada arrived in front of Mahatomara PHC under P.S Jhalda, Purulia and issued another notice in writing upon said detained person namely Jagahandhu Mahato (50) S/O Late Lukhi Narayan Mahato of Vill-Kansra, PS-Jhalda, Dist-Parolia directed him that he had legal rights to search all the members of raid purty before the search process of him. He conducted a search of all the members of us but nothing objectionable could be found on our person except our personal belongings. Govt. arms and ammunition and items mentioned in the inventory list.

In presence and under the supervision of Shri Subrata Deb SDPO Jhada, search process was conducted and during search we tound one yellow colored nylon bag inside of which one transparent white colored plastic Jarican along with deep brown colored cap containing light red colored liquid. After opening the cap automatic smell was found. We are in strong believe that it was codeline mixture and on interrogation said Jagabondhu Mahato-admitted that it was the codeline mixture and he is habituated in dealing of such clandestine illegal business of Codeline for commercial purpose for his wrongful gain, knowing the same is a punishable offence and he also stated that the person who fled away with one bettle containing Codeine mixture was his associates namely Barun Kuiry. On demand he failed to produce any valid documents or justify regarding the storage of huge quantity of contrabond codeine mixture. According to the direction of SDPO Jhalca I weighed the Jaricane and it resulted in 4519 grms including Jaricane in electronic weighing machine. On reasonable belief, an offence has been committed in respect of recovered liquid substance believed to be codeine mixture from which 112 gnns. (Including bottles each were taken as test sample and security sample in four bottles each. The said articles were seized U/S 43 of NDPS Act 1985 under proper seizure list duly signed by the witnesses as well as the accused in between 02:05 hrs to 02:45 hrs. No public witness was available there due to the dead hours of night. I also supplied a copy of seizure list to the accused. I arrested the detained person maintaining al! formalities. The seized buttles were properly sealed and labeled.

In between 02:55 hrs to 03:15 hrs I prepared another inventory list of remaining articles (after the use), containing white paper, carbon paper, brown paper, pen, rubber, stamp with pad, electronic weight machine (ranging from 10 grans to 5 kgs), scaling wax, brass seal, cardle, match box, thread, girm, one Jaricane and four small bottles (the Jaricane consists of 4519 grans and other four contains 112 grans each including bottles of seized codeine mixture) in presence of witnesses and accused. The entire process was supervised and directed by Shri Subrata Deb SDPO Jhada.

The accused persons are liable for prosecution U/S- 21(C)/29 of NDPS Act 1985 as amended up to date.

Under the above fact and circumstances I like to lodge an FIR against 1) Jagabandhu Mahato (50) S/O Late Lakhi Narayan Mahato of Vill- Kansra, PS- Jhalda, Dist- Purulia 2) Barun Kuiry and others U/S- 21(C) /29 of NDPS Act. 1985 as amended up to date and arrange for its investigation.
