Sir, I, PSI Habibur Rahman along with force return to PS and brought under seizure 01 (one) Tractor having Registration No-WB55A-2489 attached with a sand loaded trolley(approx 100 cft). The fact in brief is that today (22.08.2021) at about 22:15 hrs received a credible source information that 01 (one) Tractor was carrying sand illegally and coming from Shyamnagar ghat & going towards Jhalda side. Accordingly, myself along with C/682-Mahadeb Rajak, C/497-Ambuj Kr. Mandal, HG/1772-Fatik Ch. Kumar, HG/1681-Manmotha Kumar left PS to work out the said source information. This refers to Jhalda PS GDE No- 1032 Dated- 22/08/2021 & Jhalda PS CC No- 3242 Dated- 22/08/2021. Then, we intercepted the said vehicle at Ichag more on Jhalda Bagmundi road under Jhalda PS at about 23:45 hrs and found one Tractor having Registration No-WB55A-2489 attached with a sand loaded trolley (approx 100 Cft). But seeing the Police Party driver of Tractor fled away leaving the Tractor on road. We tried to apprehend him but failed. We waited for reasonable time but none came to spot. So there is every reason to believe that the owner and driver of above noted Tractor are dealing in sand business illegally and they do not have any proper challan or any documents related to loaded sand of above noted Tractor. So I, seized above noted Tractor having Registration No-WB55A-2489 with attached sand loaded Trolley(approx 100 cft) with proper seizure list duly sign by witness.

On return to P.S., kept the sand loaded seized Tractor at PS compound and I do here by submitting written complaint before you to start a cog case against (i) Owner and driver of Tractor having Registration No-WB55A-2489 with attached sand loaded Trolley under proper section of law.
