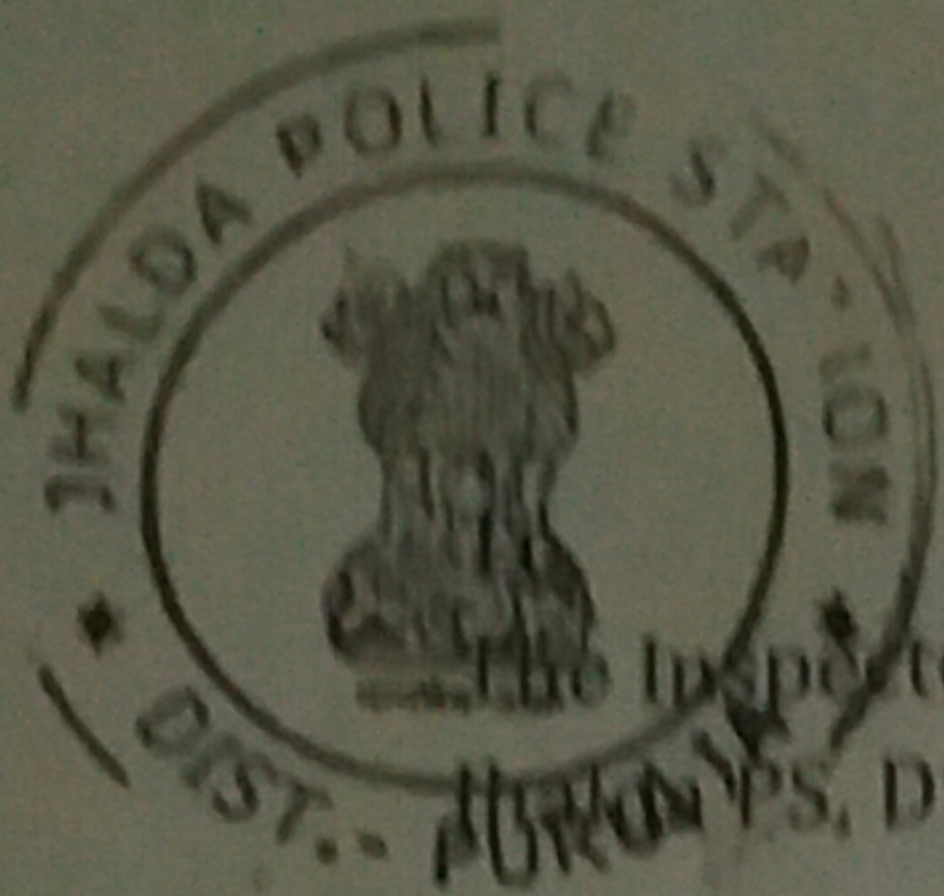

Sir,

I, ASI Sk Abdul Jamshed along with force return to PS and brought under seizure (i) 01 (one) tractor having registration No-WB55A-6163 (ii) 01 (one) tractor without number plate having Engine No RLJ2BBN1857 Chassis no MBNABACAALRJ07650 both tractors are attached with sand loaded trolley (each approx 100 cft). The fact in brief is that today (24.08.2021) I along with force namely i) C/696-Gorapada Pal ii) C/611-Jitandranath Pathak iii) NVF/778-Samir Mahato iv) HG/1807-Shyam Singh Laya were performing evening mobile duty in PS area vide Jhalda P.S. GDE No- 1114 Dated- 24/08/2021 in consonance with Jhalda PS CC No- 3272/21 Dated- 24/08/2021. During my evening mobile duty I received credible source information that two Tractors was lifting & carrying sand illegally and coming from Sarjumatu Ghat which is situated on Subarnarekha River at Jharkhand Purulia Border & coming towards Jhalda Town. Subsequently, I informed you and as per your gracious order, I placed Naka at Ichag More to work out this tip off and started Naka Checking after proper placing guard rail on the road. Thereafter I saw the two Tractors were proceeding towards Ichag More. Consequently, we intercepted the said Tractors at before Naka checking point at about 21:15 hrs and found that the vehicles as well as goods as identical as I received prior information. But seeing the Police Party driver of Tractors fled away leaving the Tractors on road before Naka checking point. We tried to apprehend them but failed. We waited for reasonable time but none came to spot. It was ascertained that the driver of the tractors loaded the said sand in cahoots with the owner of the vehicles by illegal means for selling the same to make profit by dishonestly and they had been running a clandestine business. So it is reasoned to belief that they in cahoots with the owners of the vehicles procured the said sand from Subarnarekha River from Sarjumatu Ghat by fraudulently means or theft by any means for transporting the same to run clandestine business. Ergo I, seized the vehicle (i) 01 (one) tractor having registration No-WB55A-6163 (ii) 01 (one) tractor without number plate having Engine No RLJ2BBN1857 Chassis no MBNABACAALRJ07650 both tractors are attached with sand loaded trolley (each approx 100 cft) under proper seizure list in presence of available witnesses duly signed by them. Thereafter, I brought the said tractors to Jhalda PS compound.

Under the above facts and circumstances kindly take lawful action against the Owners & drivers of the said vehicles as they committed offence U/S 379/411/414/120B of the IPC & 21 (1)(4) Mines and Minerals (R&D) Act-1957


