In producing here with 02(two) arrested accused person namely 1) Rajen Kumar (21 yrs) S/O Bijoy Kumar of Vill- Durgu, PO-Chekya, PS- Kotshila, Dist- Purulia 2) Bapi Mahato (21yrs) S/O Durga Charan Mahato Vill+Po Ichag .PS- Jhalda, Dist Purulia and along with 02 (two) seized Tractors- (i) one tractor without number plate having Engine No CJ1354/SBG05907 Chassis no MBNAJ48AFLTG42803 (ii) another tractor without any Number plate having tempred Engine No and Chassis No both are attached with sand loaded trolleys. The fact in brief is that today (16.08.2021) I along with force namely i) C/611 Jitendra Nath Pathak ii) C/497 Ambuj kumar Mandal was performing special raid duty in PS area vide Jhalda P.S. GDE No- 747 Dated- 16/08/2021 in consonance with Jhalda PS CC No- 3168/21 Dated- 16/08/2021 in PS area. During my special raid duty I received credible source information that two Tractors were lifting & carrying sand illegally and coming from Guridih Ghat which is situated on Subarnarekha River at Jharkhand Purulia Border & coming towards Jhalda Town. Subsequently, I informed you and as per your gracious order, I placed Naka at Birsha More to work out this tip off and started Naka Checking after proper placing guard rail on the road. Thereafter I saw the two tractors were proceeding towards Birsha More. Consequently, we intercepted the said Tractors at Naka checking point at about 23:05 hrs and found that those vehicles as well as goods as identical as I received prior information. On being asked, the drivers of the both vehicles disclosed their names noted in the supra. I asked both the drivers of the vehicles to produce the valid documents in respect of the vehicles as well as the loaded sand. But the drivers of those said vehicles could not able to produce any kind of documents in respect of the Tractor and the sand. I repeatedly asked both the drivers to produce the valid papers but they stated differently in different times. The incoherent statement of both the drivers purported to be a suspicious to us. It was ascertained that the drivers of both the tractors loaded the said sand in cahoots with the owners of the vehicles by illegal means for selling the same to make profit by dishonestly and they had been running a clandestine business. So it is reasoned to belief that they in cahoots with the owners of the vehicles procured the said sand from Subarnarekha River from Guridhi Ghat by fraudulently means or theft by any means for transporting the same to run clandestine business. Ergo I, seized both the tractors (i) one tractor without number plate having Engine No CJ1354/SBG05907 Chassis no MBNAJ48AFLTG42803 (ii) another tractor without any Number plate having tempred Engine No and Chassis No both are attached with sand loaded trolleys under proper seizure list in presence of available witnesses duly signed by them and also arrested the drivers namely 1) Rajen Kumar (21 yrs) S/O Bijoy Kumar of Vill- Durgu, PO-Chekya, PS- Kotshila, Dist- Purulia 2) Bapi Mahato (21yrs) S/O Durga Charan Mahato Vill+Po Ichag ,PS- Jhalda, Dist Purulia after informing the ground of arrest and issued Memo of Arrest against them. Thereafter, I brought those said tractors to Jhalda PS compound.

It is pertinent to say that the National Directive for COVID-19 Management is going on throughout the District of Purulia in view of Pandemic of COVID-19 outbreak as well as night lock Down vides order No- -753/V-ISS/2M-22/2020 dated-13/08/2021 for complete restriction of all outdoor activities from 23:00 hrs to 05:00 hrs. As such the above persons violated the supra order. There is restriction of movement except emergency purpose. But during interrogation with the drivers it is known that they did not come out for any emergency purpose. So they disobey Govt. order and committed negligent Act likely to spread infection of diseases dangerous to life and violated Quarantine rule.

Under the above facts and circumstances kindly take lawful action against the driver namely, 1) Rajen Kumar (21 yrs) S/O Bijoy Kumar of Vill- Durgu, PO-Chekya, PS- Kotshila, Dist- Purulia 2) Bapi Mahato (21yrs) S/O Durga Charan Mahato Vill+PO Ichag ,PS- Jhalda, Dist Purulia and the owners of both the vehicles as the committed offence U/S 379/411/414/188/120B of the IPC & 21 (1)(4) Mines and Minerals (R&D) Act-1957 and read with section 51(b) of Disaster Management Act, 2005.
