In producing herewith the arrested accused persons 1. Shantiram Mahato (36), s/o Lt Nemai Ch Mahato Dumadih, Ps- Joypur Dist- Purulia, 2. Tujuddin Saha (35), S/o- Ismail Saha of Vill- Karkara, Ps- Joypur Purulia and 3. Sumit Majhi (38), S/o- Parnu Majhi of Vill- Jhapro, Ps- Balidih, Dist- Bokaro Jharkhand, before you, along with seized articles like board money amounting to RS- 2545/-, 52 nos of playing cards, Cash 1250/- from their possession etc. as per seizure list.

I beg to report that on 14.08.2021 at 20:35 hrs, I, SI Dipankar Biswas, In- Charge of Baglata IC received secret information that one gambling with huge amount was going on at Karkara village, at open land near Karkara Pymari School under Joypur PS. The matter informed to the IC Joypur PS and was diazied vide Baglata I C, G.D.E No- 435, Dtd- 14.08.2021. Accordingly as per order of I/C Joypur PS I SI Dipankar Biswas along with (1) SI Maniar Rahman (2) C/3137 Rajkumar Sau (3) C/2928 Fatik Majhi, vide C.C No- 1363/21 in Govt. vehicles left for Karkara village and also informed Baglata IC Spl Byke mobile duty officer ASI Manaranjan Singh Sanjar for assist to work out the information. At about 21:10 hrs. we reached at Karkara village near Karkara Pymari School and saw light is shining in the open field and some persons were gathering there, we very slowly and cautiously approached towards the light and heard the talking of persons present there and within a few moment it was clear that the persons present there were continuing gaming with playing cards in exchange of money & Coin causing wrongful loss to one and wrongful gain to another. After that I asked my associate staffs to cordon the place and within a moment the place was cordoned by Police party. We disclosed our identity and then some persons fled away but we were able to apprehend the above noted persons. Then, I requested them to search myself and my other staff accordingly the persons searched ourselves and found nothing except wearing apparels and Mobile Phones. After that we asked their identity and the persons disclosed their name and address as noted above. It was found that a huge amount of currency note of different denomination was kept on gaming board (Four White Sand bag) and playing cards were also found. On demand the persons clearly confessed that all of them were doing gambling with playing cards in exchange of cash and coin for wrongful loss to one and wrongful gain to another. After that in presence of witnesses the board money of Rs.2545/- (Two thousand five hundred and forty five only) with different denomination, 52nos of Playing cards Four white colour sand bag, one torch light, one lighter and 02 half burned candle were seized for the gaming board in between 21:35 hrs. to 21:55 hrs. under proper seizure list. Then in presence of witnesses we searched their persons and found some personal belonging, cash (Rs. 1250/- in total) and Phones etc. All articles were seized under proper seizure list as personal property from 22:00 hrs. to 22:30 hrs. duly signed by witnesses.

As such for committing offence punishable u/s- 3 & 4 of W.B.G & P.C Act all the above noted 03 (Three) persons were arrested after maintaining all formalities of arrest, issuing arrest memo between 22:30 hrs. to 22:45 hrs.

Therefore I pray before you that one specific case may kindly be start under proper section of law against the above noted accused persons and others and arrange for its investigation.
