Sir,

In producing herewith 01 (one) arrested accused person Rabindra Kr Murmu (24 yrs) S/o-Baburam Murmu of Vill-Mochro PS-Kasmar Dist-Bokaro State-Jharkhand under arrest along with seized articles as per seizer list i.e. 12 (Twelve) Liter ID liquor "DIL. KHUSH" under proper seizure with label.

I ASI Tarapada Hazara of Joypur PS hereby lodged a written complaint against the above noted arrested accused person, to the effect that on today (27/08/2021) at about 16:05 hrs when myself along with JC-1378 Kush Dutta & HG/-Abedin Ansary were performing antierime mobile duty vide Joypur PS CC No-2970/21 Date-27/08/2021, as per my source information I reached at Jahajpur village under Joypur PS and found that the above noted accused person selling Id liquor ("DIL KHUSH") in the open place at Jahajpur village behind Harimandir. On seeing Police person, he conceal his presence at that place, but on searching we able to trace out him and also to found that 12 (twelve) liter of Illicit Liquor which was kept in open place in a bottle. On being asked he disclosed his name and address as noted above. On interrogation he stated that he was selling Illicit liquor to the local people in the open place at Jahajpur village behind Harimandir. On demand he failed to produce any valid documents in respect of selling such illicit liquor. So it is reasonable to believe that he was selling the Id liquor illegally without any documents. So I seized the same under proper seizure list on 27/08/2021 in between 18:45 hrs to 18:55 hrs & label duly signed by him and other available witness after taking 600 ML as sample in one bottle.

During further interrogation he confessed his guilt as such I arrested him today 27/08/2021 at 19:05 hrs as the accused person is liable for prosecution u/s-46A (c) of the Bengal Excise Act 1909.

I therefore pray that a specific case may kindly be started against the accused person namely Rabindra Kr Murmu (24 yrs) S/o-Baburam Murmu of Vill-Mochro PS-Kasmar Dist-Bokaro State-Jharkhand. U/S-46A (c) of the Bengal Excise Act 1909.
