Sir,

In producing herewith 02 (two) arrested accused persons namely (1) Ajoy Bagti (47 yrs) S/o Raghu Bagtiof Vill-Khedatard PS-Joypur Dist-Purulia (2) SK Rejaul (24 yrs) S/o-Late SK Rejak of Vill-Tentlo PS-Purulia (M) Dist-Purulia under arrest along with seized articles as per seizer list i.e. 14 (fourteen) bottle ID liquor "DIL KHUSH" under proper seizure with label.

1 ASI Nisith Ch Das of Joypur PS hereby lodged a written complaint against the above noted arrested accused persons, to the effect that on today (29/08/2021) at about 18:35 hrs when myself along with JC-1380 Golam Kadir Ansary, NVF-659 Bhaskar & NVF-889 Binoy Mahato were performing anticrime SPL Mobile duty at PS area vide Joypur PS CC No-2989/21 Date-29/08/2021, as per my source information I reached at Khedatard village under Joypur PS and found that they above noted accused persons selling Id liquor ("DIL KHUSH") in the Ajoy Bagti S/o-Raghu Bagtiof Vill-Khedatard PS-Joypur Dist-Purulia. On seeing Police person, they conceal their presence at that house, but on searching we able to trace out them and also to found that 14 (fourteen) bottle of Illicit Liquor (DIL KHUSH) which was kept conceal at his house. On being asked they disclosed their name and address as noted above. On interrogation they stated that they were selling Illicit liquor to the local people in his house at Khedatard village. On demand they failed to produce any valid documents in respect of selling such illicit liquor. So it is reasonable to believe that they were selling the Id liquor illegally without any documents. So I seized the same under proper seizure list on 29/08/2021 in between 18:40 hrs to 18:55 hrs & label duly signed by him and other available witness after taking 600 ML as sample in one bottle.

During further interrogation they confessed their guilt as such I arrested them today 29/08/2021 at 19:05 hrs to 19:10 hrs as the accused persons are liable for prosecution u/s-46A (c) of the Bengal Excise Act 1909.

I therefore pray that a specific case may kindly be started against the accused persons namely (1) Ajoy Bagti (47 yrs) S/o-Raghu Bagtiof Vill-Khedatard PS-Joypur Dist-Purulia (2) SK Rejaul (24 yrs) S/o-Late SK Rejak of Vill-Tentlo PS-Purulia (M) Dist-Purulia U/S-46A (c) of the Bengal Excise Act 1909.
