Sub: Prayer for lodging F.I.R. against arrested accused persons namely Partha Rajwar (32 yrs) S/o Shaktipada Rajwar of Vill-Mirdih PS-Joypur Dist-Purulia & 10 others.

With due respect I SI Abhijit Singha of Joypur PS, beg to submit before you that on 06/08/2021 at about 11:05 hrs while myself along with force were performing Special Mobile duty at PS area and conducting raid against non-wearing of mask physical distancing maintaining Joypur Bazar near Chatipara as per order of my superior vide Govt. Memo No. 715-Home (Com)RIM/ (Com)-92/21 dated. 17.04.2021 of Govt. of West Bengal regarding any violation of masks and social distance norms should be strictly dealt with and Order No-753/IV-ISS/2M-22/2020 Date-29/07/2021, Joypur PS GDE No-237 Date-06/08/2021 & CC No-2740/21 Date-06/08/2021 and found the following persons were roaming near Joypur Bazar near Chatipara without any face cover / mask & were gather near Joypur Bazar near Chatipara without maintaining physical distancing. Inspite of several request & reminder they refuse to wear mask and roaming at public place. To prevent the spread Covid-19 pandemic situation, I asked them to wear mask but they did not comply my request & roaming near Joypur Bazar near Chatipara without wearing face cover / mask. Myself along with accompanied force detained them at Joypur Bazar near Chatipara they were coming from others villages. On being asked the following persons could not able to give any satisfactory answer for their presence at public place without face cover / mask. In this pandemic situation of CORONA Virus/COVID-19 the above noted persons violated the order duly promulgated by Government order vide Memo No. 715-Home (Com)RIM/ (Com)-92/21 dated. 17.04.2021 of Govt. of West Bengal regarding any violation of masks and social distancing norms should be strictly dealt with and Order No-753/IV-ISS/2M-22/2020 'Date-29/07/2021. As such the following persons violated the order during this pandemic situation. Moreover the detained persons refused to comply the direction given by the Central Govt. & the State Govt. to combat the severity of COVID-19 pandemic. The accused persons also tried negligently to spread infection of disease dangerous to life. Accordingly the following persons were arrested on 06/08/2021 from 21:35 hrs to 22:40 hrs, after maintaining all formalities regarding arrest prepared arrest memos and brought them to P.S.
