Sub: Prayer for lodging F.I.R. against arrested accused persons namely **Santosh Mahato (28 yrs) S/o-Late Girdhari Mahato of Vill-Uparbatri PS-Kotshila Dist-Purulia & 08 others.**

Sir,

With due respect I SI Abhijit Singha of Joypur PS, beg to submit before you that on 07/08/2021 at about 21:25 hrs while myself along with force were performing Special Mobile duty at PS area and conducting raid against non-wearing of mask physical distancing maintaining Joypur Bazar near Hospital More as per order of my superior vide Govt. Memo No. 715-Home (Com)/RIM/ (Com)-92/21 dated. 17.04.2021 of Govt. of West Bengal regarding any violation of masks and social distance norms should be strictly dealt with and Order No-753/IV-ISS/2M-22/2020 Date-29/07/2021, Joypur PS GDE No-308 Date-07/08/2021 & CC No-2752/21 Date-07/08/2021 and found the following persons were roaming near Joypur Bazar near Hospital More without any face cover / mask & were gather near Joypur Bazar near Hospital More without maintaining physical distancing. Inspite of several request & reminder they refuse to wear mask and roaming at public place. To prevent the spread Covid-19 pandemic situation, I asked them to wear mask but they did not comply my request & roaming near Joypur Bazar near Hospital More without wearing face cover / mask. Myself along with accompanied force detained them at Joypur Bazar near Hospital More they were coming from others villages. On being asked the following persons could not able to give any satisfactory answer for their presence at public place without face cover / mask. In this pandemic situation of CORONA Virus/COVID-19 the above noted persons violated the order duly promulgated by Government order vide Memo No. 715-Home (Com)/RIM/ (Com)-92/21 dated. 17.04.2021 of Govt. of West Bengal regarding any violation of masks and social distancing norms should be strictly dealt with and Order No-753/IV-ISS/2M-22/2020 Date-29/07/2021. As such the following persons violated the order during this pandemic situation. Moreover the detained persons refused to comply the direction given by the Central Govt. & the State Govt. to combat the severity of COVID-19 pandemic. The accused persons also tried negligently to spread infection of disease dangerous to life. Accordingly the following persons were arrested on 07/08/2021 from 21:40 hrs to 22:55 hrs, after maintaining all formalities regarding arrest prepared arrest memos and brought them to P.S.

- (5) Karimuddin Ansary (47Yrs) S/o-Uzman Ansary of Joypur Ansary Mahalla PS-Joypur Dist-Purulia
- (6) Ashok Ruhidas (46Yrs) S/o-Parikhit Ruhidas of Vill-Ketiya PS-Kotshila Dist-Purulia
- (7) Julen Kumar (53Yrs) S/o-Aghari Kumar of Vill-Tatuara PS-Kotshila Dist-Purulia
- (8) Sarifuddin Ansary (24 yrs) S/o-Afijuddin Ansary of Vill-Chitmu PS-Kotshila Dist-Purulia

All the arrested accused persons are liable for prosecution U/S-269/188/34 IPC & 51 (1) (b) of Disaster Management Act, 2005.

As the offence is bailable, So all the arrested accused persons were released on bail after furnishing bail bond vide Joypur PS GDE No-328 Date-07/08/2021.

Hence it is prayed before you that above mentioned persons may kindly be prosecuted U/S - 269/188/34 IPC & 51 (1) (b) of Disaster Management Act, 2005. Copy of order attached herewith,
