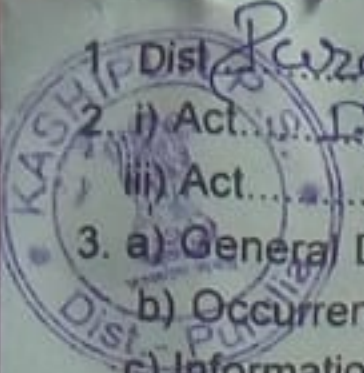

Sub: Request for lodging F.I.R. against arrested accused persons namely (1) Uttam Kr Mahato (43 Years) S/O Arun Kr Mahato of vill - Sindurpur, P.S - Santaldih, Dist - Purulia and 06 (Six) others.

Sir,

In producing herewith 07 (Seven) arrested accused persons namely (1) Uttam Kr Mahato (43 Years) S/O Arun Kr Mahato of vill - Sindurpur, P.S - Santaldih, Dist - Purulia (2) Biswajit Mandal (23 Years) S/O Ashish Mandal of vill - Dhanjore, P.S - Kashipur, Dist - Purulia (3) Rohit Mahato (21 Years) S/O Lt Upashi Mahato of vill - Chuna, P.S - Kashipur, Dist - Purulia (4) Tapas Bauri (47 Years) S/O Ramprasad Bauri of vill - Barahir, P.S - Para, Dist - Purulia (5) Rajaram Mahato (36 Years) S/O Lt Mukunda Mahato of vill - Kalajhore, P.S - Kashipur, Dist - Purulia (6) Akash Murmu (27 Year) S/O Nirmal Murmu of vill - Bansraya, P.S - Kashipur, Dist - Purulia (7) Tushar Kanti Rajwar (26 Years) S/O Lt Kalobaran Rajwar of vill - Kumardih, P.S - Kashipur, Dist - Purulia.

I beg to state that today (08.08.2021), I was directed to find out whether the guidelines of Govt. regarding pandemic situation has been implanted properly by Kashipur PS area or not vide Kashipur P.S CC No 1770/21 Dtd 08.08.2021. Accordingly, I had been to near Kashipur Traffic More at about 21.05 hrs and found that a gathering appeared at near Kashipur Traffic More, none of them was wearing mask. On seeing Police party they have tried to escape from the grip of police party but they failed to escape due to efficiency effort of police party. On being asked he disclosed their identity as noted above.

They violated the order duly promulgated by government through public servants and through media etc for prevention of attack from CORONA Virus/COVID-19. They are creating annoyance to the society & violated govt. order. Though in view of Pandemic of COVID-19 outbreak vide Govt. of India order No - 753/IV-ISS/2M-22/2020 dated - 29.07.2021 of the Government of West Bengal, Wearing of facial mask has been mandatory in public places in the current pandemic disaster situation, on violation of using mask and social distance norms should be strictly dealt with.

I arrested them for Disobedience to order duly promulgated by public servant after maintaining all rules of arrest, Issued arrest Memo. I informed them & their relative regarding the ground of arrest i.e. as per section 3 of the Epidemic Diseases Act, 1897, provide penalties for disobeying any regulation or order made under the Act. These are according to Section 188 of the Indian Penal Code (Disobedience to order duly promulgated by public servant). A prima facie there were sufficient evidences to secure their detention. All the process was done in between 21.15 hrs and 21.45 hrs. There was every chance of breach of peace and requiring of offence if not arrested.

Therefore, I pray a specific case may kindly be lodge against the above noted arrested accd. persons namely (1) Uttam Kr Mahato (43 Years) S/O Arun Kr Mahato of vill - Sindurpur, P.S - Santaldih, Dist - Purulia and 06 (Six) others who disobeyed Govt. order and committed negligent Act likely to spread infection of diseases dangerous to life and violated Quarantine rule U/S 188/34 IPC and Section 51(1) (b) National Disaster Management Act- 2005 and arrange for investigation.
