In producing herewith one Md. Manjarul Hossain (32 yrs) s/o- Md. Jahangir Hoque of Vill + PO- Jhunka, PS-Beldanga, Dist- Murshidabad driver of truck having Regd. number WB 57 B/4844 with seized articles 1)Truck bearing Regd. No- WB 57 B/4844 loaded with appx. 250 nos of different sand bags,2) 02 pieces old Iron made "Palaba" basing in a latter to 120 control of the control of th

"Belcha" having iron butt and 3) 02 pieces Iron made "Dhama".

The nub of the fact in a nutshell is that today on 26.08.2021 at 05:55 hrs duty officer PSI Gouranga Roy received one source information to the effect that one Truck is loading sand at Dwarakeswar river for transportation. The matter was noted in GD vide Kashipur PS GDE No- 1084 dtd- 26.08.21 and informed to O/S Kashipur PS . To work out the information I, ASI Sibaram Bauri of Kashipur PS along with (i) C/2280 Akinchan Mondal and JC/1373 Saddam Sk both of Kashipur PS, Dist-Purulia, left PS vide Kashipur P.S C.C No.- 1967/21 dtd- 26.08.21. At 06.45 hrs we reached at Dwarkeswar River bed and kept the Govt. vehicle on the bank of river and proceeded towards the spot by foot. We came to find that few persons were loading sand bags in the Truck bearing Regd No- WB 57 B/4844 near Paharpur River Bridge under PS- Kashipur. Seeing the Police party other persons fled away from the spot leaving the truck. After chased we are managed to apprehend one person. On being interrogation he disclosed his name and identity as Md. Manjarul Hossain (32 yrs) s/o- Md. Jahangir Hoque of Vill + PO- Jhunka, PS- Beldanga, Dist- Murshidabad and also stated that he is the driver of Truck bearing Regd. No WB-57 B/4844 and stated that he is dealing in such business accompany with his owner. On being asked he failed to produce any documents in respect of the vehicle as well as of the loaded sand Hence, I seized the above noted Truck along with loaded with appx. 250 nos of different sand bags, 02 pieces old Iron made "Belcha" having iron butt and 02 pieces Iron made "Dhama" in between 07.15 hrs to 07.40 hrs. Also arrested Md. Manjarul Hossain (32 yrs) s/o- Md. Jahangir Hoque of Vill + PO-Jhunka, PS - Beldanga, Dist- Murshidabad driver of truck having Regd. number WB 57 B/4844 after maintaining all the rules and guidelines of apex. Court as well as of NHRC and brought the said seized articles with arrested accd. person to Kashipur PS.

As there is every reason to believe that the drivers and owners of the said truck with ill motive were transporting sand illegally without any valid documents in support of carrying sand and violating the Govt. order they

are doing such illegal activity.

Hence, I do hereby lodge this complaint against the owners and drivers of above noted seized Truck bearing Rgd No- WB 57 B/4844 for starting a case under proper section of law and arrange for investigation.
