I, SI Pradyot Banerjee of Kenda PS, Dist- Purulia in producing herewith the following accused Persons namely (i) Biswajit Mahato (25 Yrs.) S/o Niranjana Mahato of Vill. Bhadsa, PS- Tamna, Dist. Purulia (ii) Ashok Kr. Mahato (45 Yrs), S/o- Lt. Babulal Mahato of Vill- Punura, PS- Kenda, Dist- Purulia (iii) Arup Ratan Mudi (33 Yrs), S/o- Yudisthir Mudi of Vill- Banbahal, PS- Purulia (M), Dist- Purulia (iv) Abdul Rahaman Khan (22 yrs.), S/o- Abul Hossain Khan of Vill- Gharpathar, PS- Indpur, Dist- Bankura (v) Bablu Mahato (29 Yrs.), S/o- Sadananda Mahato of Vill- Kuruftopa, PS- Kenda, Dist- Purulia (vi) Kiriti Mahato (29 Yrs.), S/o- Ajit Mahato of Vill- Jambad, PS- Kenda, Dist- Purulia & (vii) Debasish Mahato (29 Yrs) S/o Paban Mahato of Vill. Purulia do hereby lodge a written complaint against them to the effect that today on 08/08/2021, as per direction while I along with NVF/673 Rabi Singh Sardar, NVF/0239 Rabindra Nath Mahato and HG- 1933 Lakhandar Mura all of Kenda PS engaged in day mobile duty at Kenda PS area and while we reached at Kenda Bazar under Kenda PS at about 14:05 hrs. found that the above noted persons along with others moving here and there without wearing of mask during this pandemic situation and not maintaining the social distancing and on seeing the police parties some of them fled away and we are able to arrest the above noted accused persons, as there is every possibility that the above noted accused persons moving here and there without wearing a mask which violates the compliance of norms of wearing of mask during this pandemic situation and committed negligent act likely to spread infection of disease dangerous to human life and violated Government rule. I offered them for medical checkup, but they denied stating themselves ok, hence, I could not.

Therefore, I pray that a specific case may kindly be start against above noted arrested accused person as per proper section of law.
