Sir,

In producing herewith seized vehicles (Tractors) without number plate bearing Engine No- 3100DL83B709745F3 and Chassis No- AZQSG719788SM attached with Trolley loaded with sand approx. 100 Cft. without any number plate. The fact of the case in brief is that on 26/08/2021 I along with C/2644 Mithun Duley and HG/1926 Bidhan Tantubai all of Kenda PS were on night mobile duty. During mobile duty on 27/08/2021 at about 04.35 hrs. when we reached at Darodih Morh found that the above noted tractor was coming from Bhandarpura side towards Darodih Morh. On seeing the Police party driver of the said tractor stopped his tractor in a distance and he fled away after keeping the tractor near Darodih Morh. We searched the said tractor and found that the tractor was loaded with sand. Hence we waited there some times and held an enquiry about the said tractor but none turned up and demanded as actual owner of the said tractor or the sand and ascertained that the owner and driver of the said tractor loaded the said sand by illegal manner for selling the same to make profit by dishonestly in a clandestine business. So seized the tractor bearing Engine No- 3100DL83B709745F3 and Chassis No- AZQSG719788SM attached with Trolley loaded with sand approx. 100 CFT without any number plate under proper seizure list in presence of available witnesses duly signed by them. Thereafter arranging driver from my source and brought the tractor at Kenda PS. So it reason to belief that driver and owner of the said seized tractor procured the said sand by fraudulently means or theft by any means for transporting the same to clandestine business.

Under the above facts and circumstances kindly take lawful action against the owner and driver of the Tractor having Engine No- 3100DL83B709745F3 and Chassis No- AZQSG719788SM attached with Trolley loaded with sand.
