Respected Sir,

I, SI Subhendu Sekhar Bera of Kenda PS, Dist- Purulia in producing herewith one arrested accused person namely Lakhikanta Mahato (37 Yrs), S/o – Lt. Sripati Mahato of Vill- Kuchung , P.S – Kenda, Dist- Purulia with seized articles i.e. 1) One white colour jarican containing Approx 10 Ltrs. ID Liquor 2) 08 pcs plastic glasses (3) Approx 01 Ltr ID liquor as sample which was collected from seized articles in SI No-01 & kept in a bottle which were seized under proper seizure list.

I beg to submit that today (27-08-2021) during special raid duty acting on a secret source information myself along with (1) C/1572 Badal Mahapatra, (2) C/2519 Arun Duley of Kenda PS conducted raid in the tea stall of accused person namely Lakhikanta Mahato at about 15.35 hrs and found that he was keeping and selling of ID liquor to the others at his tea stall at Lakradungri. Seeing the Police party, all customers fled way but we managed to apprehend the accused person. On being asked he failed to produce any valid licence /documents in respect of storing and selling of ID liquor. As such I seized 1) one white colour jarican containing Approx 10 Ltrs. ID liquor 2) 08 pcs plastic glasses (3) Approx 01 ltr ID liquor as sample which was collected from seized articles in SI No-01 & kept in a bottle under proper seizure list in presence of witnesses and duly signed by them and also arrested the above noted person after informing him the ground of arrest and after observing all legal formalities. The seized articles were properly sealed and labelled in presence of witnesses. I also arranged to inform his family member about his arrest by police.

Under the fact and circumstances, I therefore pray that a specific case may kindly be start against Lakhikanta Mahato (37 yrs), S/o – Lt. Sripati Mahato of Vill- Kuchung , P.S – Kenda, Dist- Purulia as per proper section of law.
