Sir,

In producing herewith 05 (Five) arrested accused persons 1) Lakhiram Kisku (21 Yrs) s/o-Som Kisku of vill-Damrughutu 2) Mantulal Kumar (19 Yrs) s/o-Sasankar Kumar @ Laxman of Vill-Chekya 3) Kirtan Kumar (22 Yrs) s/o-Chaitu Kumar of Vill-Majhidih 4) Dhupal Kumar (25 Yrs) s/o-Sristi Kumar of Vill-Bararola 5) Debashis Kumar (19 Yrs) s/o-Gobardhan Kumar of vill-Mutukura all of PS-Kotshila Dist- Purulia.

I beg to state that today (06.08.2021), I SI Jyotilal Mahato with C/1265 Sanjoy Chakraborty & C/138 Bani Bandopadhyay were directed to find out whether wearing of mask by the public has been properly maintained at Rakhbore More or not. Accordingly, I had been to Rakhbore More at about 20:55 hrs found that a gathering at Rakhbore More, none of them were wearing mask. On seeing Police they tried to escape from the grip of police party but some of them failed to escape due to efficient effort of Police. On being asked, they disclosed their identity as noted above & they were loitering there without any purpose.

In this pandemic situation of CORONA Virus/COVID-19 the above noted persons violated the order duly promulgated by government and order vide memo no. 715-Home(Com)/RIM/(Com)-92/21 dated. 17.04.2021 of Govt. of West Bengal regarding any violation of masks and social distance norms should be strictly dealt with and memo no. 486-CS/2021 dated 24.04.2021 of Govt. of West Bengal & Order no- 753-ISS/2M-22/2020, Dt- 14/06/2021 & Order no- 753/II-ISS/2M-22/2020, Dt- 28/06/2021 & Order no- 753/III-ISS/2M-22/2020, Dt- 14/07/2021 & Order no-753/IV-ISS/2M-22/2020, Dt- 29/07/2021. So, I arrested them for disobedience of order duly promulgated by public servant. After maintaining all rules of arrest, issued memo of arrest. I informed them & their relatives regarding the ground of arrest i.e. as per section 3 of the Epidemic Diseases Act, 1897, provide penalties for disobeying any regulation or order made under the Act. These are according to Section 188 of the Indian Penal Code (Disobedience to order duly promulgated by public servant). At prima facie there were sufficient evidences to secure their detention. All the process was done in between 21:05 hrs to 21:25 hrs. There was every chance of breach of peace and requiring of offence if not arrested.

Therefore, I pray to you that a specific case may kindly be lodged against the above noted accused persons as they disobeyed Govt. order and committed negligent Act likely to spread infection of diseases dangerous to lie and violated the rule U/S 188/34 IPC and Section 51(1) (b) National Disaster Management Act- 2005 and arrange for investigation.
