I beg to state that today (02.08.21), I was directed to find out whether the lock down has been implanted properly at Manbazar PS area or not. This refers to Manbazar PS GDE No- 71 Dtd. 02.08.21. Accordingly, I along with C/ 1191 Subodh Hansda, C/1119 Susanta Singha had been to PS area side no one is listening dispute mike perching in the area. The above noted persons walking freely in the public streets without wearing a mask. They are not following the rules and regulations of Corona disease at about- 21:15 hrs I found that the above noted persons were roaming aimlessly at PS area. Myself along with force detained them at Challa more under Manbazar PS. On being asked the above accused persons could not able to give any satisfactory answer for that movement on road and public place. Though lockdown is going on throughout the District of Purulia in view of Pandemic of COVID-19 outbreak vide Govt. of India consolidated order No-40-3/2020-DM-1 (A) Date-24/03/2020 and further modified dated- 25/03/2020, 27/03/2020, 02/04/2020, 03/04/2020 & 10/04/2020, and further notification dated 17.04.21 Govt of West Bengal vide No. 715- Home (Cons)/RIM(Cons)- 92/2021. & Order No- 753/11 - ISS/2M-22/2021 dated 14.07.2021 & Extended till 15<sup>th</sup> August 2021 for complete restriction measure. As such the above persons violated the order during this pandemic situation duly promulgated by Govt. of West Bengal vide Order No- H & F W/120/20 dated 22.03.2020 which is extended till now. Moreover all the detained persons were refuses to comply the direction given by the Central Govt. & State Govt. to combat the severity of COVID-19 pandemic. All the accused persons also tried negligently to spare infection of disease dangerous to life.
