Sub: FIR for illegal ploughing

Respected Sir,

With due respect, as per Bihar Gazette notification (9192-vif-319-R, notification no- 5399-VIF-98/47-R date-22/05/1947) there is 95 acre forest land present. At the request of the majority of the people of Bhurasole, we started plantation over 10 Ha of place. But when we started plantation of that place with the help of maximum people of Bhurasole and also help of Bhurasole JFMC members, on that moment Gobinda, Gorai , s/o- Bijoy Gorai at vill- Bhurasole interrupts of forestry work without any legal reason. When we asked the reason, he said that he has some land under Bhurasole mouza. So we told him to submit his legal document, but he failed to submit such documents that means he encroach the forest land. He started to cultivate forcefully obstructing the forestry work and violating 32g of IFA,2(ii) of FCA 1980, 120B of IPC and provokes some people and threatens to kill my staff which is violation of 186, 189, 190 of IPC. I lodge a FIR at Manbazar-1 police station(Ref Manbazar P.S GD no-444/21 dt-11/07/2021). After noticed him, he came and agreed that he is guilty and he made illegal work in forest department's land (statement attached). He requested us that no case be filled against him on 14/07/2021 and he also said that he will never do any work at forest departmental land which is against forest law.

But last night he again ploughing at departmental land and threatened my staffs and also JFMC members and at the mid night he uprooted approx. fifteen(15) no of Kadam seedlings which is planted on 2ndjuly under scheme MGNREGS and he again violated 32g of IFA, 120B, 183,186,189,190 of IPC and 2(ii) of FCA 1980.

In this circumstances, I hereby request you to look into the matter and take necessary steps regarding the above matter and lodge a FIR with your police station and oblige me thereby.

According to 12/12/1996 Godavarmancase(T. N GodavarmanThirumulpadvs union of India &ors on 12 december,1996 Indian kanoon) Hon'ble court has concluded the followings:-

(A) The forest conservation Act, 1980 was enacted with a view to check further deforestation which ultimately results in ecological imbalance; and therefore the provisions made therein for the conservation of forest and fore matters connected there with, must apply to all forest irrespective of the nature of ownership or classification thereof. The word "forest" must be understood according to its dictionary meaning. This description cover all statutorily recognized forests, whether designated as reserved, protected or otherwise for.

(B) The purpose of section 2(i) of forest conservation Act. The term "forest land" occurring in section 2 will not only include "forest" as understood in the dictionary sense, but also any area recorded as forest in the GOVT. record irrespective of ownership. This is how it has to be understood for the purpose of section 2 of the Act. The previous enacted in the forest conservation Act. 1990 for the conservation of forests and the matters connected therewith must apply clearly to all forests so understood irrespective of ownership or classification thereof.
